#### RECOGNITION/PRESENTATION/DELEGATIONS

## Central Okanagan Public Schools Reporting Draft Implementation

Jordan Kleckner, Director of Instruction – Learning and Innovation, provided an overview of the District's engagement timeline, from November 2021 to June 2022, with schools, administrators, educators, the Central Okanagan Parent Advisory Council, and District working groups and committees regarding the new K-12 Ministry Reporting Order and the transition to an aligned, district-wide student reporting process. The new Ministry Reporting Order, the redesigned curriculum, and the collective feedback from all stakeholders was considered while drafting the District K-12 Student Reporting Guidelines. A District Assessment and Reporting website for educators was also developed with information, guidelines, samples, and examples of student reporting. The 2022-2023 school year is an optional draft implementation year of the Central Okanagan Public Schools Draft K-12 Student Reporting Guidelines in preparation for full implementation in 2023-2024.

## The Draft Central Okanagan Public Schools Student Reporting Guidelines (K-12)

Jordan Kleckner, Director of Instruction – Learning and Innovation, provided an overview of the Central Okanagan Public Schools Draft K-9 Student Reporting Guidelines and the Draft Grade 10-12 Student Reporting Guidelines. The Guidelines are being fine-tuned based on feedback collected from all District stakeholders during the 2022-2023 optional draft implementation year. The finalized District K-12 Student Reporting Guidelines will be brought forward to the January Education and Student Services Committee meeting for recommendation for approval by the Board of Education. Province-wide implementation of the new Ministry Reporting Policy Framework will occur in the 2023-2024 school year.

## ITEMS REQUIRING SPECIAL MENTION

The Deputy Superintendent of Schools shared that 18 delegates from the Yukon First Nation Education Directorate are arriving in Kelowna on Sunday, November 20, 2022. They will be visiting schools throughout the week and learning about the role of the Indigenous Student Advocate and how the District is decolonizing learning environments and indigenizing the curriculum.
