RECOGNITION/PRESENTATION/DELEGATIONS

SUPERINTENDENT'S REPORT

The Superintendent reported the following:

- The Kelowna Art Gallery is currently hosting their annual "Art in Action" show which continues until June 24, 2012. A 25 year anniversary book has been developed which celebrates the wonderful works of art created throughout the District. The book was produced by Harry Tonn, Teacher Mount Boucherie Secondary School.
- The School District will be hosting the 35th annual BC Interior Jazz Festival in Kelowna from April 12 14, 2012.
- The District's annual Years of Service Recognition/New Employee Welcome Reception will be held on Thursday, March 29, at 4:00 pm at the Coast Capri Hotel.
- Earth Hour 2012 will take place from 8:30 pm 9:30 pm on Saturday, March 31st.
- The Kraft Hockeyville Finale Celebration takes place at the Royal LePage Place on the Westside on Saturday, March 31st. Events will occur throughout the day from 8:00 am 9:30 pm.
- The District will be receiving more information from the Ministry of Education regarding regulations and expectations from Bill 22 legislation. It is anticipated that further direction will be provided regarding expectations for the management team in terms of implementation, reporting requirements for the new Learning Improvement Fund, a consultation plan and issuing of report cards. The Superintendent will be consulting with the Central Okanagan Teachers' Association and CUPE regarding the use of learning improvement funds and other resources to support the District's most vulnerable students.

TRUSTEES QUERIES/COMMENTS

Trustee Gorman

Requested information on how possible teacher job action may impact upcoming graduation ceremonies and events.

The Superintendent responded that the District is in the early stages of assessing the possible job action impact and it would be premature to predict how graduation events may be affected. Each school celebrates graduation events in a different manner with a wide variety of community, parent and teacher involvement and support. The commencement exercise and grad dinner and dance are Board-sanctioned events. These will proceed; however, the format may be different than from previous years.

Trustee Gorman

Requested that, once graduation activity formats have been established, the information be communicated to parents/students.

The Superintendent advised that all graduation dates have been established and will take place as scheduled. Information will be communicated to parents and graduates.

Trustee Baxter

Requested information on Board-sanctioned events that may have volunteer supervisors only.

The Superintendent responded that school administrators will review events scheduled and assess the level of supervision and adult presence required.

The Director noted that the large increase in secondary class composition changes is due to the beginning of the new semester in February.

Interim Policy 386 - "Employee Use of Electronic and Social Media Communication"

In the absence of Trustee Fraser, Chairperson of the Education and Student Services Committee, the Assistant Superintendent provided background information on the development of the interim policies (Policy 386 for employees and Policy 486 for students), which included extensive research and input from partner groups over the past year. The interim policies were sent to PACs and COPAC for feedback in December 2011 and again in January 2012. PAC feedback was received from 5 elementary, 3 middle and 4 secondary schools. 10 PACs supported the interim policies, 2 PACs provided conditional support and one PAC remained opposed to the interim policies as currently presented. Once the interim policies receive final Board approval, staff and the subcommittee will commence revision of the District's Network User Agreements for employees and students, school Codes of Conduct, and the development of K-12 curriculum around digital citizenship.

Trustees requested information on administrator access to social media sites on school properties and discussed provisions for acceptable social media use during lockdown or emergency situations. The Assistant Superintendent and Jon Rever, Director of Instruction K-12, advised that school administrators have access at their schools to social media sites, and social media use during emergency situations will be addressed in Network User Agreements and Codes of Conduct, as well as in lockdown procedures and drills in schools.

Trustees discussed PAC feedback, personal cell phone use, safety standards and exposure limits, and the information contained within the policies.

The Board agreed to add "School and District Codes of Conduct" to the consequences outlined in Student Policy 486. The policy will be amended to read "Use of electronic and social media communication which violates the terms outlined in policy, the Student Network Account and Internet Agreement, or the District or School Code of Conduct may result in serious consequences including definite or indefinite suspensions and/or police intervention".

Trustee Gorman, Chairperson of the Finance and Legal Committee, provided a brief review of the information contained within the summary. The Board reviewed the summary.

Policy 453 and Regulations 453R "Child Protection"

The Superintendent advised that the policy and regulations were sent as information items to PACs and COPAC in December. One school PAC expressed concern regarding the training required for volunteers, given the struggle to find volunteers, and the cost for training. The Superintendent confirmed that language contained within the policy is consistent with provincial standards and cannot be amended. The expectation is that volunteers who work with students on an ongoing basis will receive training. This does not prohibit schools from using volunteers on a "one off" basis. School administrators will determine which of their volunteers fit the criteria and require training. A training module will be developed for new volunteers and existing volunteers will work with a "train the trainer" module.
