#### RECOGNITION/PRESENTATION/DELEGATIONS

# **2021 Summer Reading at Quigley Elementary School**

Desmond Sjoquist, Principal – Quigley Elementary School, Sarah Murdoch Black and Tess Perry, Teachers at Quigley Elementary School, presented Quigley's 2021 Summer Reading Program. During summer vacation, many students are not actively engaged in reading and learning, experience a 'summer-slide' in their academic achievement and are particularly at risk for a loss of literacy skills. The staff at Quigley Elementary School wanted to ensure students maintained their passion and motivation for reading throughout the summer by opening the school's library every Wednesday morning from July 7<sup>th</sup> to August 18<sup>th</sup>. Two hundred students, who would be in grades 1 to 5 in September 2021, were invited to participate with their families in this free summer reading opportunity. The Teacher-Librarian, Learning Assistance Teacher, a grade 3 teacher, and the Library Assistant collaborated with the principal to ensure that at least one teacher was available to interact with all attending students and read with targeted struggling readers. Due to COVID-19 protocols, only students were allowed in the library to sign out books; however, many students spent time in the school courtyard reading with a teacher or their parents.

In addition to taking six library books home each week, free 'read and recycle' books were available outside the library in the school courtyard for students and families to take and permanently add to their home libraries. Several large bins of sports equipment and game instructions, provided by a Kelowna sports company, could be signed out by families to use to promote physical literacy at home. As summer progressed, many parents began to bring fruits and vegetables from their gardens that could be shared with any of the visiting students and families, contributing to a strong community vibe. Feedback regarding the summer reading opportunity was positive from staff, students, and parents. When school reconvened in September, students that had attended summer reading at the Quigley library spoke of their excitement about being at school during the summer.

#### **New Ministry Draft Reporting Order**

Jamie Robinson, Acting Assistant Superintendent, and Jordan Kleckner, Acting Director of Instruction – Learning and Innovation, provided a presentation about the new Ministry K-12 Draft Reporting Order and how the District has been preparing for the transition since 2016.

The District has been operating under two different Ministry reporting orders since 2016. Prior to 2016, the District was using Schedule 1 (K-12), a traditional reporting system with proficiency scales for kindergarten to grade 3, letter-grades for grades 4 to 9, and letter-grades with percentages for grades 10 to 12. In 2016, an additional Schedule 2 (K-9) was introduced by the Ministry of Education with schools having the option to use various proficiency scales for kindergarten to grade 9, while continuing with letter grades and percentages for grades 10 to 12. Additionally, the District was able to experiment with better forms of reporting and communication to families. In September 2022, a new Ministry Reporting Order is expected to go into effect which will align reporting across the schools in the province of BC under one kindergarten to grade 12 reporting policy.

During the last five years, the District has been preparing for the Ministry's new reporting policy through the work done by teachers and educators on the District Assessment/Communicating Student Learning Committee. Interim Guidelines for Communicating Student Learning (K-9)

were created to provide educators with criteria for quality communication of student learning. Teachers and educators across the District continue to meet at their schools to move forward with changes to the report card. The District has introduced strength-based assessment language, a more effective way of communicating student learning with families, and has placed students more at the center of taking ownership of their own learning. Central Okanagan Public Schools is in a good position for the new Ministry Draft Reporting Order to be finalized and take effect in September 2022.

#### **Updated Board/Authority Authorized (BAA) Course List**

Al Lalonde, Assistant Superintendent, shared that a full audit of all Board/Authority Authorized (BAA) courses being used by the District was completed in Spring 2021. Sixteen Board approved courses have since been updated using the Ministry of Education's new template and added to the archived BAA files with a total of ninety-one courses currently available for schools to use. New BAA courses will be brought forward to the January 5, 2022 Education and Student Services Committee Meeting for recommendation to the Board of Education for approval.

# ITEMS REQUIRING SPECIAL MENTION

#### **Intercultural Competency Training**

Terry-Lee Beaudry, Deputy Superintendent of Schools, shared that Intercultural Competency Training is one of the priorities of the Equity in Action Agreement for Truth and Reconciliation and the District is considering different approaches to the learning. Twelve school counsellors are participating in Core Indigenous Cultural Safety (ICS) Mental Health Training, offered through the Provincial Health Services Authority Indigenous Health Program, from January 2022 through to Summer 2022. This 10-hour online certificate program is designed to increase knowledge, enhance self-awareness, and strengthen skills of those who work both directly and indirectly with Indigenous people. The District's Human Rights Committee is currently exploring the topic of intercultural competency training for all staff.
