The District is required to report back to the BC Human Rights Council in the Fall. The Committee requested that staff look at how other districts obtained this information. The consensus was that the Assistant Superintendent and the Director of Instruction – Human Resources will compile all the necessary data to complete the annual report in September and provide an update at a future Human Resources and Staff Services Committee meeting.
