"A Mindful Teaching Community: Possibilities for Teacher Professional Learning" describes a grassroots professional learning journey wherein a group of practicing classroom teachers research their teaching practices and the role of mindfulness in their learning. Using a mix of methods, this book illustrates how the stories of an educator can be uncovered, investigated, and transformed through practicing mindfulness within a community. Through the stories told in this collection, the teachers learn to see greater connections between their individual ways of thinking, their actions, and the greater system they live and work in. The storied inquiry of the educators offers unique possibilities for teachers' professional learning." (Amazon.ca)

Teacher Mr. McLeod described the 'mindfulness practice' and its influence on enhancing engagement, teaching and learning. Mindfulness practices include a foundation focused on kindness, an open mind and an open heart and are tailored to meet different needs and to address different goals.

<u>Presentation: Using Alternative Forms of Communicating Student Learning to Support the Implementation of the Redesigned Curriculum</u>

In attendance: Jamie Robinson, District Principal for Leadership & Learning in Innovation

Ashley Ragoonaden, Principal, KLO Middle School Karin Dumont, Teacher, KLO Middle School Melanie Charest, Teacher, KLO Middle School Mr. Robinson reported on the implementation of District Policy 506 - *Principles of Assessment*. Teachers Charest and Dumont, who are collaborating on implementing the redesigned curriculum and piloting an alternate form of communicating student learning, described the pedagogical shift and the success of the pilot. Student learning and involvement have been achieved through the use of learning records in digital portfolios that included teacher feedback sections to identify areas and strengths as well as next steps in the learning journey. The elimination of grades provides students and parents more information and shifts the conversation to accomplishments and goals. Student testimonials were presented that emphasized the appreciation for the new model.

The Board of Education and Superintendent/CEO commended Ms. Charest and Ms. Dumont for their work.

Assistant Superintendent Jon Rever introduced an upcoming Community Forum hosted by the Rutland Family of Schools on January 30th, from 6:00 to7:30pm.
