PRESENTATION

Report to the Finance and Audit Committee - Initial Communication on Audit Planning for the Year Ended June 30, 2021

In attendance: Tyler Neels, Grant Thornton LLP

Kate Cumming, Grant Thornton LLP

Tyler Neels and Kate Cumming of Grant Thornton LLP, presented a high-level review of the audit engagement and proposed audit strategy for the upcoming audit of the financial statements of the District for the year ended June 30, 2021. Also discussed was the COVID-19 financial reporting impacts as well as the audit plan and risk assessment, including processes and deliverables. It was also reported that the Office of the Auditor General (OAG) has included School District No. 23 (Central Okanagan) in the extended sample of school districts in the province which involves Grant Thornton LLP to gather additional financial information on behalf of the OAG. The Grant Thornton representatives responded to questions.

Depending on the COVID-19 Health Orders, the audit will either be completed remotely, on site, or a hybrid of both remotely and on site.

The audit results will be presented at the September 22, 2021 Finance and Audit Committee Meeting. Final financial statements are due to the Ministry of Education by September 30, 2021.

The Committee Chairperson thanked the representatives from Grant Thornton LLP for their presentation.

2021/2022 CommunityLINK Allocations

The Assistant Secretary-Treasurer presented the recommended allocations for the 2021/2022 CommunityLINK funding. Central Okanagan Public Schools will receive \$1,258,789 for the 2021/2022 school year. The school meals program will receive over 61.6% of the funding. It is recommended that the remaining funds be distributed to continue to maintain and support District programs such as the Young Parent Program at KSS, mental health initiatives, and Health Promoting Schools initiatives.
