# Partner Updates:

# Robyn Boffy - RCMP

There has been an increase in fighting in Rutland area. Noticing a difference when a duty patrol officer responds vs a school resource officer.

## <u>Curtis Schreiber – Principal CNB</u>

Receiving calls for more support from police liaison. No school from Mar-Aug has led to an increase in social media fighting vs face to face conversation.

#### Lori Dawson-Bedard - COTA

Would like to see mandatory wearing of masks for all stakeholders in schools in light of recent confirmed Covid-19 cases. Received and distributed masks for every COTA member in schools.

# <u>Gerry Guiltenane – Crimestoppers</u>

Receiving reports or information on bullying incidents and graffiti on city/public properties.

## <u>Deannie Dacosta Zahara – COPAC</u>

Worried debris going onto playground where students may play with it and dealing with traffic issues at schools (i.e. RSS construction). Wondering if notices could be provided to schools for projects from Mitch Vanaller at Operations.

#### <u>Teri Wishlow – CUPE</u>

Concerns raised about drug paraphernalia at school sites. The wearing of face masks makes it hard to identify/recognize people who shouldn't be there.

## Brad Sieben – City of Kelowna Counsellor

There is a development e-mail list which provides information on what is happening that can be provided to Al. Drug paraphernalia incidents increasing in Kelowna. Left meeting at 10:00 a.m.

#### Al Lalonde – Assist Superintendent

Advised GRIP training will be provided to all Admin regarding gangs and guns impact on youth. All school sports coaches must complete online concussion training before coaching. Interior Health is at our table regarding suicide screeners and better communication regarding students who are hospitalized.

## Ryan Donn – City of Kelowna Counsellor

Advised new Superintendent for RCMP is Kara Triance. Seeing a rise in petty crimes/theft in Kelowna. Seems to be connected to mental health or drug addiction issues. Still working on a Community Safety Plan.

# Penny Gambell – Lake Country Counsellor

Community is seeing an increase in small crimes. Concerns regarding homelessness and congregating in vacant homes. Construction at George Elliott/HR Grenda Middle School is being well managed -no traffic issues. Vaping not seen around schools as much due to the push on regulations. Mask use concerns in public to cut down on transmission like they have in China.

#### Carly Suddard – Brain Trust

Concussions may be a contributing factor for the reasoning/motivation for petty crimes or drug use in the community.

## Lee-Ann Tiede – Board of Education

Attending event at RSS for Remembrance Day so apologized for late arrival to meeting. Will pass on information at next meeting regarding RCMP SROs,

# Moyra Baxter – Board of Education

Support the recommendation that RCMP School Resource Officers be the focus on the next meeting.
