## Policy Committee Public Meeting Report - October 5, 2022

## PUBLIC OUESTION/COMMENT PERIOD

There were no public questions/comments.

## **COMMITTEE MEMBERS QUERIES/COMMENTS**

Trustee Johnson asked about Policy 390 that had been listed on the October 5, 2022 Report as an item for a future Policy Committee meeting, but was not on the March 1, 2023 Agenda.

The Superintendent of Schools/CEO advised that this Policy had been brought forth by a former Trustee and had been updated with names and titles, but that there was not a reason to bring it forward again at this time.

The COPAC Vice-President and the COTA First Vice-President queried the process of developing a Policy to handle harmful public comments made at board meetings, that contain misinformation and discrimination.

The Superintendent of Schools/CEO advised that District Staff were already looking into this matter.

#### **DISCUSSION/ACTION ITEMS**

# <u>Annual Review of Committee's Mandate, Purpose and Function: Policy 168 - Policy Committee</u>

The Chair stated that the Committee reviews *Policy 168 – Policy Committee* on an annual basis. There are no recommended changes to the policy at this time.

### **Amendments to Policy 115 - Inaugural and Annual Board Meetings**

The recommended amendments include the reference to Secretary-Treasurer changed to Secretary-Treasurer/CFO; and the removal of the administration of an Oath of Allegiance at the Inaugural Meeting.

Trustee Geistlinger further recommended that item 3 of the Policy be amended regarding the "destroying of the ballots (if any)", in case the Board separates the agenda items between the inaugural meeting and the first regular meeting of the Board:

"3. The Board may separate the agenda items between the Inaugural and the first regular public meeting if desired. Items 2.1 - 2.8, and 2.14 shall be included in the Inaugural meeting and items 2.9 - 2.14 shall be included in the first regular public meeting of the Board."

Trustee Geistlinger further recommended that the term "cheque signature plate" in item 2.8 be updated to read "cheque signature form".

## **Amendments to Policy 387 - Freedom of Information and Protection of Privacy**

The recommended amendments are required to bring Board Policy into alignment with the changes to the *Freedom of Information and Protection of Privacy Act*. This includes the addition of a paragraph on Responsibility.

THAT: The Board of Education approve the amendments to Policy 387 - Freedom of Information and Protection of Privacy as attached to the Agenda, and as presented at the March 1, 2023 Policy Committee Meeting.

The COPAC Vice-President suggested that parents annually review and sign the FOIPOP consent form, rather than just signing at student registration, as family situations can change throughout the years. The Superintendent of Schools/CEO advised District staff would look into this.

#### DISCUSSION/INFORMATION ITEMS

## **DRAFT Policy 388 - Public Interest Disclosure Act**

The Superintendent of Schools/CEO advised that the *Public Interest Disclosure Act* came into effect December 1, 2019. The purpose of the *Public Interest Disclosure Act* is to provide a mechanism that allows current and former employees within the BC public service to raise serious or systemic issues of wrongdoing for investigation, without exposing those employees to any risk of retaliation. The draft Policy attached to the Agenda was received from the BC Public School Employers' Association.

Trustee Geistlinger queried some of the terms under Definitions:

- Possible duplication of "Discloser"
- "Employee"-"past and or present employee of the School District"

Trustee Johnson queried the acronyms FIPPA and FOIPOP. The Superintendent of Schools/CEO advised that these acronyms were interchangeable.
