#### RECOGNITION/PRESENTATION/DELEGATIONS

### **Foundation Skills Assessment**

Kevin Kaardal, Superintendent of Schools/CEO, and Jon Rever, Assistant Superintendent, gave an overview of the Foundation Skills Assessment (FSA). As a requirement of the BC School Act, the FSA is an annual province-wide assessment of all BC students' academic skills in grades 4 and 7 and provides valuable information to parents, teachers, schools, school districts and the Ministry of Education on how well students are doing in the foundation skills of Reading, Writing and Numeracy. FSA results are about more than the overall performance of the provincial school system; the results show where individual students excel and where they need assistance, allowing parents and educators to make early interventions that can enhance success later in a child's schooling. In recognition of the unique school year due to the COVID-19 pandemic, the administration of the FSA is being postponed until January 18 – February 26, 2021 which will provide schools with more time to prepare for the annual assessment.

# **Outcome:**

The Education and Student Services Committee recommended to the Board of Education:

THAT: The Board of Education write a letter to the Ministry of Education regarding the Fraser Institute's misuse of Foundation Skills Assessment results and request that the Ministry of Education post the results, internally, to Districts;

AND THAT: The Board of Education undertake a media campaign before the Foundation Skills Assessment results are posted.

# <u>Proposal for Substantive Change – Academy of Indigenous Studies (George Elliot Secondary School)</u>

Joanne De Guevara, District Principal - Indigenous Education, Naim Cardinal, District Vice-Principal - Indigenous Education, and Cliff Schwartz, Principal – George Elliot Secondary School, presented a proposal for an Academy of Indigenous Studies at George Elliot Secondary School. The Academy of Indigenous Studies is a full 20-credit program for students in grades 10 through 12 and provides Indigenous and non-Indigenous students authentic, hands-on Indigenous teachings aimed at enriching understanding of the local culture, building self-esteem and increasing a sense of identity and connectedness to the school and community. This is a unique and innovative opportunity for students to gain a greater sense of how their interaction with local Indigenous culture and their leadership in responding to the Truth and Reconciliation's Calls to Action has an effect on future generations of British Columbians.

### **Outcome:**

The Committee recommended that the Board of Education approve the Proposal for Substantive Change – Academy of Indigenous Studies (George Elliot Secondary School), as attached to the Agenda, and as presented at the November 18, 2020 Education and Student Services Committee Meeting.

# <u>Proposal for Substantive Change – Academy of Art and Design (George Elliot Secondary School)</u>

Cliff Schwartz, Principal – George Elliot Secondary School, Kevin Nickel, Teacher – George Elliot Secondary School, and Rochelle Youngberg, Teacher – George Elliot Secondary School, presented a proposal for an Academy of Art and Design at George Elliot Secondary School. In the Academy, students will prepare for a potential career in the modern arts sector including animation, fine arts, filmmaking, photography or design. Students will develop their collaboration and innovation skills, build portfolios, meet and work with experts, and hone their chosen craft based on an individual development plan. Students will enhance their knowledge, understanding and appreciation of the technical aspects of the modern arts and leave school prepared for post-secondary opportunities and an industry that is experiencing growth in the Okanagan and beyond.

### **Outcome**:

The Committee recommended that the Board of Education approve the Proposal for Substantive Change – Academy of Art and Design (George Elliot Secondary School), as attached to the Agenda, and as presented at the November 18, 2020 Education and Student Services Committee Meeting.
