The PacificSport Okanagan presenters provided an overview of the organization's background and the programs and services it offers for students. PacificSport Okanagan is funded in part by investments from various partnerships, including the Province of BC, ViaSport and Okanagan municipalities. Funding is also generated internally through revenue received from programs that are provided, and from private sponsors.

The application process is open to any student in the Central Okanagan School District and includes a registration form and required letters of reference from an academic sponsor and a primary sport organization. The current program fee is \$2,000 for the academic year. Fees may be reduced based on support for students through financial awards, and students have the opportunity to apply for financial assistance.

The Board reviewed the information provided and the requirements of the Central Okanagan School District teacher assigned to the program to develop, administer, evaluate and report on the educational learning outcomes of the students, and, as the program develops, possibly provide social and emotional support as well. For the current year, there are 29 students enrolled. Should the number of students fall below 13 - 15, the program would need to be reviewed with regard to financial sustainability.

As outlined in Policy 542 - Proposals for Educational Programs with External Partnerships, once the Board has approved a proposal for external partnership, a Memorandum of Understanding will be entered into between the Board of Education and the external group. Any proposed changes to approved external partnerships must be brought to the Education and Student Services Committee in December of each calendar year for review, and a recommendation for any change must be forwarded to the Board of Education for approval.
