The Board recognized Sgt. Ann Morrison for her work in building partnerships that have helped address a variety of social, health and education issues within School District No. 23 schools and the community.

The Chairperson made the following declaration:

School District No. 23 (Central Okanagan) declares Sunday, April 22, 2012 as "Earth Day" in School District No. 23 (Central Okanagan) supporting environmental awareness.

SUPERINTENDENT'S REPORT

The Superintendent reported the following:

- On Thursday, April 12, 2012, the Central Okanagan Bursary & Scholarship Society will be honouring their founders and donors for their significant contributions to the society. The Donor Appreciation Tea will take place at 4:00 pm at Central School Programs and Services.

PUBLIC QUESTION/COMMENT PERIOD

The purpose of this public question/comment period is to provide an opportunity to members of the gallery to ask a question or comment on any items on the agenda. The total time for this period shall normally be 15 minutes. A person wishing to speak is requested by the Chairperson of the Board to state his/her name and provide, if possible, a written copy of the comments.

TRUSTEES QUERIES/COMMENTS

Trustee Baxter

Noted the many recognitions made by the Board of Education, e.g. Earth Day and Earth Hour, and questioned why the District is not recognizing National Volunteer Week, which takes place the week of April 16th.

The Superintendent responded that the District's practice is to celebrate and recognize its volunteers during SD23 Education Week, which traditionally takes place the first week of March each year.

Trustee Pendharkar

Requested information on the protocol for Trustees accepting the numerous invitations they receive.

The Board Chairperson responded that the previous Board had instructed the Superintendent to request that Principals/Vice-Principals invite school liaison trustees and other trustees to events taking place in their schools. It would be up to the individual trustee to either accept or decline.

Trustee Gorman

Requested information on the recent announcement by the Provincial Government regarding capital funds for schools to help drive down carbon emissions. The funds are for schools to invest in energy efficiencies for improving the environment.

The Secretary-Treasurer responded that districts have not received details on the funding allocation. If the funds are allocated out to districts, SD No. 23's share of funding would normally be 4%. If districts must apply for grant funding, SD No. 23 would be in an excellent position to apply for a grant as the sustainability office is actively working on reducing consumption.

Trustee Gorman

Queried whether a process was in place for allocation of the Bill 22 Learning Improvement Fund.

The Superintendent provided a brief review of the intent of the Learning Improvement Fund and the funding amount to be received by the District. Consultation will take place with CUPE regarding a potential increase for CEA hours. During the Human Resources staffing week, school administrators are being asked to identify potential issues where the funds could be used, and are being asked to discuss possible use of funds with their staff. Consultation has begun with the COTA regarding class composition and class size and other potential allocation of resources. Once the District has a plan in place for allocation of funds, the plan will be brought to the Board of Education for approval and then submitted to the Minister of Education.

Trustee Gorman

Questioned whether a plan was in place to communicate Learning Improvement Fund information to school staff.

The Superintendent responded that conversations have taken place with COTA executive members, and principals have been asked to discuss possible uses of and the application process for Learning Improvement Funds with their staff.

ACTION ITEMS

2012 - 2013 School Calendar

The Director of Instruction - Human Resources reviewed the school calendar presented for 2012/2013. A brief background was provided regarding the inception of the District's two-week spring break, which has been in place for the past eight years. Partner group input has been requested and considered in the development of the local school calendar. The District's Implementation Day has been moved from the third week of September to October 5th and the calendar includes the new BC Family Day which is set for the third Monday in February. Feedback from parents, the COTA and the Central Okanagan Principals' and Vice-Principals' Association is in support of the calendar; however, CUPE is not in support of the two-week spring break due to lost wages, daycare issues and financial hardship for single parent families.

- 1. The Superintendent direct school Principals, in consultation with staff and parents, to establish a site-based calendar for the 2012-2013 school year and to make the calendar available to all parents by May 31, 2012; and,
- 2. In establishing such calendars, principals must:
 - a. Conform to the School Act and Regulations, applicable Collective Agreements, and School District No. 23 Board Policy.
 - b. Schedule school parent/teacher conference times.
 - c. Schedule their school's calendar as follows:

Maintain the Ministry prescribed minimum number of minutes of student instruction per day (Kindergarten to Grade 7-4.75 hours per day, middle/secondary grades 7 to 12-5.15 hours per day). *By withdrawing three non-instructional days from the standard school calendar to the summer and adding a small number of minutes per school day (3 minutes for Elementary and 4 minutes for Middle/Secondary), we would be maintaining the same total hours of instruction for students and meet the minutes required for 187 days of instruction (as in the B.C. Standard School Calendar).

Trustees discussed the proposed calendar, and the Partner Group Representatives provided feedback. Trustee Baxter will forward a Notice of Motion regarding looking into the feasibility of providing employment opportunities for CUPE members who are not offered work during the two-week spring break.

INFORMATION ITEMS

Superintendent's 2012/2013 District Budget Recommendations

7:03 pm: Trustee Gorman left the meeting. 7:04 pm: Trustee Gorman returned to the meeting.

The Superintendent provided a presentation on the 2012/2013 district budget recommendations and reviewed the revenue and expenditure changes for 2012/2013. Per pupil funding of \$6,784 per School Age Full Time Equivalent students remains the same for the coming school year. Provincial funding has provided an increase in Operating Grants and additional funding is being provided to address specific objectives established by the Ministry. Included in these objectives is a three-year commitment to the new Learning Improvement Fund. The District has a larger than usual surplus due to increases in provincial holdback distribution over the past two years, the paring down of the overall school district operation due to budget shortfalls in previous years, cost saving resources initiated by the District, and District programs which are generating funds, e.g. International Education, WorksafeBC Claims Management and investment income.

It was noted that the Board had previously addressed item #4 on page 8 of the Superintendent's Recommendations (*Leadership Development – Expand Vice-Principal Complement*) and had agreed to support this line item.

Trustees discussed the information provided and the process for budget deliberation and approval. The next step for the budget process will be the Board deliberation of the Superintendent's recommendations at the April 18, 2012 Public Finance and Legal Committee Meeting. It is anticipated that a preliminary 2012/2013 budget will subsequently be approved by the Board at the April 25, 2012 Public Board meeting.
