our dedicated counsellors and staff. The flag at KSS is flying at half-mast in their honour. Our thoughts are with students' families and friends and all affected by this tragic accident.

The COTA President requested confirmation that the District received funding to purchase a school site in the Wilden area of Kelowna. The Secretary-Treasurer/CFO confirmed that the Province has supported a site acquisition in the Wilden area for a new school site.

- The number of exposures in the Central Okanagan Public Schools' community continue to decrease. Schools in the Rutland area have been impacted by recent exposures and are being monitored in collaboration with Interior Health.
- Registrations for vaccines are now being accepted for students between the ages of 12-18.
