TRUSTEES QUERIES/COMMENTS

Trustee Fraser

Queried why a Capital Plan was not submitted to the Ministry for 2014/2015 and whether this was due to the administrative savings that all school districts were required to achieve and submit to the Ministry.

The Secretary-Treasurer responded that the Ministry of Education did not request a Capital Plan submission for 2014/2015. The Ministry has requested an updated Capital Plan for 2015/2016 as a funding envelope has been established for capital projects.

Trustee Baxter

Noted that, as a result of the recent federal election, Stephen Fuhr has been elected as the new Member of Parliament for Kelowna-Lake Country, and Dan Albas is returning as the Member of Parliament for Central Okanagan-Similkameen-Nicola.

It was agreed that the Board Chair would send letters of congratulation to MP Stephen Fuhr and MP Dan Albas, as well as a letter of thanks to former MP Ron Cannan for his service to the community during his term as the Member of Parliament for Kelowna-Lake Country.

2015/2016 Five Year Capital Plan Submission

THAT: The Board of Education approve the 2015/2016 Capital Plan, as attached to the agenda and as presented at the October 28, 2015 Public Board Meeting.

The Secretary-Treasurer reviewed the information contained in the Capital Plan. Existing facilities have been examined in order to determine the feasibility of implementing the Board's approved grade reconfiguration as outlined in the District's Long-Term Facility Plan.

Trustees discussed the priority order on the Plan which lists the construction of an Okanagan Mission Junior Middle School as the first new construction priority, followed by a new Glenmore Secondary School and a new Lake Country Junior Middle School. Fourth on the priority list and the number one replacement project is the replacement of Rutland Middle School. The Central Okanagan School District is one of the few districts in the province with increasing enrolment, which translates into minimal competition for funding for new construction; however, all 60 school districts are competing for funding for replacement capital projects.

As the construction of a new Okanagan Mission Junior Middle School has progressed to phase two for approval at the Ministry level, the District has been directed to list construction of the new middle school as the number one priority.

INFORMATION ITEMS

Superintendent's Emergent Issues

We Day - October 21, 2015

- Approximately 600 Central Okanagan School District students and staff attended this year's We Day Conference in Vancouver.
- The Assistant Superintendent commended the We Day Committee Members for their outstanding organization of this year's event.

"Drop Everything and Read Day" - October 26, 2015

- Students across the District participated in this provincially coordinated event.
- The Assistant Superintendent commended Misty Smith, President of the Central Okanagan Teacher-Librarians' Association (COTLA), and the District's teacher-librarians for their organization of the event.

Enrolment Numbers - Central Okanagan School District

- The District's enrolment numbers currently sit at 380 students over projected numbers, which is 320 students more than last year's enrolment.
- Support for the new students and the opportunities presented by the increased enrolment numbers will be discussed with the Board and Partner groups.

Foundation Skills Assessment (FSA) – Grade 4 and Grade 7 Students

- Administration of the FSA will take place from January 11 to February 19, 2016. This information will be shared with parents and discussed with Partner groups.

Action Schools! BC

- Action Schools! BC is a provincial government initiative designed to assist schools in creating and implementing action plans to promote healthy living, while achieving academic outcomes and supporting comprehensive school health.
- Action Schools! BC has been placed temporarily on hold as the province reviews all school-based healthy living programs in an effort to improve coordination and integration.
- Workshops and new equipment/resources will not be available until a new model of delivery is established.

Mar Jok Elementary School - 2015 "Green" Award

- Mar Jok Elementary School has recently received the Southern Interior Construction Association Okanagan Kootenay Commercial Building Green Award, which recognizes all of the "green" initiatives incorporated into the school building.

Annual Report on Special Program: Hiring Exemption

The Human Rights Commission has approved the preferential hiring of teachers with Aboriginal ancestry. The Special Program provides approval for the hiring of a proportion of teaching staff to the proportion of Aboriginal students. An annual report is required by the Human Rights Commission. By September 2015, a total of 51 teachers had identified themselves as having Aboriginal ancestry.

<u>District Health Promoting Schools Committee – Yearly Summary of School Planning Council</u> <u>Reports and School Goals Related to Health Promoting Schools 2014-2015</u>

In 2014-2015, 20 District schools reported a school goal related to Health Promoting Schools, with six schools reporting a focus area related to Health Promoting Schools. Schools continue to place a strong emphasis on social responsibility, self-esteem, social/emotional support, and establishing a community culture through increasing student engagement.

Ombudsperson's Report of Files Closed – July 1 to September 30, 2015

<u>Ministry of Education New Curriculum and Provincially-Mandated Competencies – Release Time– Letter to Parents, October 19, 2015</u>

District staff have been working with the Central Okanagan Teachers' Association (COTA) through the Joint Educational Change Committee to develop a plan for the structure of the 10 hours of release time being provided by the Ministry. It is anticipated that the Ministry framework will be made public in early November. Approximately 80 teachers (selected by COTA) will be trained to provide support to schools. Early dismissal days in November have been previously scheduled (by zone) and will proceed as planned. The 10 hours of release time are in addition to any early dismissal days previously scheduled.

The COPAC President and the COTA President expressed an interest in having a staff member from the Ministry of Education provide a local presentation to parents explaining the new curriculum and provincially-mandated competencies. Senior staff will work with COPAC and COTA in arranging the presentation by Ministry of Education personnel.
