PUBLIC QUESTION/COMMENT PERIOD

Tony Kreutzer expressed concerns that the new Indigenous-Focused Graduation Requirement may reduce opportunities for secondary students to select elective courses, especially French Immersion students.

The Deputy Superintendent of Schools shared that the District is exploring a variety of ways to support the implementation of the new Indigenous-Focused Graduation Requirement. Based on community feedback, the province may change the effective date.

The Superintendent of Schools/CEO stated that the District will ensure secondary students know about the options available to meet the new Indigenous-Focused Graduation Requirement.

Shane Styles followed up on his past inquiry about continuing to webcast Public Board Meetings via Zoom as well as questioned how the Board responds to public questions/comments.

The Board Chair stated that the Board may answer general questions during the public question/comment period; however, sometimes the information is received and forwarded to the appropriate staff member to respond to the member of the public.

Shane Styles commented that he would have loved to ask the teachers who presented the 'Reading is Feeling' information if masking impacted the children's ability to read.

Lisa Aschenbrenner stated that she did not receive a response to her questions about the rapid antigen tests sent home with students.

The Board Chair shared that questions related to the safety of the rapid antigen tests were sent to the District Health and Safety Officer to respond. The Superintendent of Schools/CO stated that he would follow up with Lisa Aschenbrenner after the meeting.

School District Portable Information

With the continued enrolment increase, most schools in the District are operating beyond their Ministry's calculated operating capacity. Portables have been added to school sites to accommodate the student enrolments. Since 2018, the District has added 23 portables to its inventory and has funded \$4.96 million in purchasing and moving portables to accommodate the enrolment growth. Based on the projections for September 2022, and the reopening of École Bellevue Creek Elementary School and Webber Road Elementary School, the District will purchase 2 portables, move 13 portables, and move 2 modulars to accommodate enrolment for September 2022. These moves and purchases are estimated to cost approximately \$2.5 million.
