The Superintendent and the Chair of the Safe Schools Committee provided background information on the program which has been successfully implemented in other jurisdictions. On May 27, 2015, the pilot program will provide an opportunity for two classes (60 students) to go through the process. Interior Health Authority, the Kelowna General Hospital, the Kelowna Fire Department, BrainTrust Canada, the BC Coroner's Office, and the RCMP are involved in the program. Students will be taken through stations in the hospital emergency ward, the trauma room and the physiotherapy department. A mock crash scene will be in place and students will be provided with the opportunity to experience what could happen in an emergency, and what it would be like to have a resulting disability and how to deal with that disability. RCMP members will provide a presentation on licensing, texting/phoning while driving, and alcohol abuse. At the end of the day, students will be provided with the opportunity to hear a speaker who has received a brain injury in a car accident describe what his life is like after the accident. On May 28, 2015, 30 students will participate in the process.
