# **Presentation: School Opening Report – Part 2**

- Presenter: Hugh Gloster, Superintendent of Schools

The Superintendent reviewed the information contained within the report. To date, the District's enrolment shows an increase of 14 students over last year (currently 21,327 students). Variations in student head count and FTE (full time equivalency) occur as a result of short-term international education students, adult students, and cross-enrolled students (between schools and districts) who are enrolled in various specialty programs and academies. It is expected that, once these student numbers have been factored in, the District will be providing services to approximately 22,000 students. The Ministry snapshot for funding has been extended from September 30<sup>th</sup> to October 17<sup>th</sup> for the 2014/2015 school year. Approximately 16 of the 216 students who chose alternate education providers have returned to District schools.

A review of student migration and transfers, teacher hiring, transportation, career preparation, portables and vacant classrooms, and extra-curricular activities was provided.

It was noted that transportation assistance is available to parents whose children are eligible for transportation however, due to remoteness, the District is unable to provide a bus. The transportation assistance is capped at the average cost of transporting a student for the school year.

Shelley Courtney, Glenmore Elementary Parent, requested information on the significant drop in student numbers at several of the District's schools, i.e. Raymer Elementary School.

The Superintendent responded that some students have moved to other education providers, and several neighbourhoods have changed, due to being more transient in nature.

# TRUSTEES QUERIES/COMMENTS

#### **Trustee Fraser**

Queried whether the Central Okanagan School District would be putting together a Capital Plan submission.

The Secretary-Treasurer responded that the government has requested transportation requirements from school districts, however are not expecting a Capital Plan submission this year. The Central Okanagan School District's Capital Plan will not have any significant changes from last year as no additional funding has been received.

# **Trustee Brinkerhoff**

Noted that many favourable comments have been received regarding the District's *What's Next?* booklet for senior students, which provides detailed information including post-secondary options, career choices and scholarship information.

The Superintendent responded that the document is developed by school counsellors, in particular Karen Gilbert, George Elliot Secondary School, and Marilyn Green, Okanagan Mission Secondary School, and is posted to the District's website. The booklet is used in Planning 10 courses and all senior students are provided with information regarding access to the document. The Superintendent will convey the Board's appreciation to those involved in creating the booklet.

# Vivian Evans, COPAC Vice President

Requested more information on the Rutland Family Hub initiative being developed at Pearson Road Elementary School.

The Board Chair responded that the concept was initiated by Robert Zoppi, Principal of Pearson Road Elementary School. The concept involves various agencies using the school site to provide services to the community. An initial presentation on the Rutland Family Hub was provided to the Education and Student Services Committee on October 1<sup>st</sup>.

The Superintendent advised that the initial presentation on October 1<sup>st</sup> was to provide information on the proposal and to receive approval in principle to proceed with next steps. A detailed presentation will be provided to the Education and Student Services Committee at the November 5<sup>th</sup> Committee meeting. The School District's contribution will be to provide after-hours access to Pearson Road Elementary School. The community agencies involved will hire a coordinator to develop and oversee the services that will be offered within the Rutland Family Hub.

# **Lake Country Schools Consultation Meetings**

- Meetings are taking place with the Parent Advisory Councils of schools in Lake Country regarding preliminary planning for catchment area changes. A meeting has taken place at Oyama Traditional School (September 29, 2014), and meetings are scheduled at Davidson Road Elementary School (October 9, 2014), and École Peter Greer Elementary School (October 14, 2014). An online survey will also be used to gather community feedback.

It is anticipated that feedback and direction from the community will have been received prior to the Winter Break. Depending on feedback received, the District may be in a position to consider changes for September 2015.
