## **Reports/Matters Arising**

January 9, 2013 Committee Report - Received

#### Recognition/Presentations/Delegations

# 1. BC Technology Education Association – Best Practices Guide

Dan Hurd, Teacher from Mount Boucherie Secondary School, provided a presentation pertaining to information in the 2011 British Columbia Technology Education Association 'Best Practices Guide'. The Technology Educators of Kelowna (TEK) have met regarding student safety and student engagement in shop classes. The TEK recommends limiting shop class size to 22-26 students to improve student engagement and overall safety in the classroom.

#### **Discussion/Action Items**

# 1. Proposal for Substantive Change (Academy of Indigenous Studies) – Mount Boucherie Secondary School (MBSS)

Joanne De Guevara, District Principal - Aboriginal Education, and Kevin Kaiser, Aboriginal Education Curriculum Resource Teacher, provided a brief background on the proposal to establish an Academy of Indigenous Studies. Scott McLean, Principal – Mount Boucherie Secondary School was available for questions. The Academy of Indigenous Studies would provide Aboriginal and non-Aboriginal students a rigorous academic program and strong cultural connections to the Okanagan people and territory. The proposed suite of courses for the Academy include: Okanagan Language 10, 11, 12; Leadership 10, 11, 12; R'Native Voice 10, 11, 12; English First Peoples 10, 11, 12; First Nations Studies 12; and First Nations Art Studio 11, 12. There is no cost to students who enrol in the Academy of Indigenous Studies.

#### **Outcome**

The Committee recommended that the Proposal for Substantive Change (Academy of Indigenous Studies) be sent to the Board of Education for approval for implementation at Mount Boucherie Secondary School beginning in September 2013 pending MBSS Parent Advisory Council approval.

2. Proposal for Substantive Change (Dr. Knox Middle School Golf Academy) – Dr. Knox Middle School Rod Baruta, Principal – Dr. Knox Middle School, presented the proposal to establish a Golf Academy at Dr. Knox Middle School. Dave Roberts, Teacher – Dr. Knox Middle School, was available to answer questions. Dr. Knox Middle School currently offers two team sport Academies in Soccer and Hockey. Mount Boucherie Secondary School is the only other school in the District that offers a Golf Academy. The Dr. Knox Golf Academy would provide the option of an individualized sport for students. The Academy would also provide opportunities for students to develop a wide variety of skills (i.e. as coaches, entrepreneurs, retailers, golf course architects/designers, volunteers, etc.) in addition to learning the sport of golf. The cost associated with this Academy would be \$400 per participant based on 24 students.

#### **Outcome**

The Committee recommended that the Proposal for Substantive Change (Dr. Knox Middle School Golf Academy) be sent to the Board of Education for approval for implementation at Dr. Knox Middle School beginning in September 2013.

#### 3. Proposal for Substantive Change (Music Academy) – Glenmore Elementary School

Des Sjoquist, Principal – Glenmore Elementary School, provided background on the proposal to establish a Music Academy at Glenmore Elementary School. The Fine Arts and Music programs are already a part of Glenmore Elementary's identity; therefore, the staff and parents believe a Music Academy would be beneficial to the Glenmore students. The Music Academy would provide a wide range of instrumental lessons for all Glenmore Elementary families. Music lessons would be provided before school, two times a week over a ten week period several times throughout the year. The Academy would be a non-profit program for Glenmore Elementary. The cost to users would be approximately \$45-55 per term, depending on the number of participants in the session.

#### **Outcome**

The Committee recommended that the Proposal for Substantive Change (Music Academy) be sent to the Board of Education for approval for implementation at Glenmore Elementary School beginning in September 2013.

**4.** Board Authorized Course (BAC) Proposal – Athlete 10, 11, 12 and Individual Sports Training 11 and 12 The Superintendent provided a brief review of the proposed BACs.

Athlete 10, 11, and 12 is an athlete development program in which students learn about three main movement streams consisting of strength training, gymnastics, and track and field. Individual Sports Training 11 and 12 is a personalized learning pathway and curriculum that allows for the assessment of student learning while participating in their specific sport. While involved in organized, specific, high performance sport, and through training and competition, students will learn about the aspects of being an athlete including technical skills, tactical skills, mental training, teamwork and leadership, and physical conditioning.

#### Outcome

The Committee recommended that BAC Athlete Training 10, 11, 12 and Individual Sports Training 11 and 12 be sent to the Board of Education for approval pending Parent Advisory Council and School Planning Council approval from the school where the course will be offered or a Board approved Memorandum of Understanding outlining the roles and responsibilities of all parties involved with School District No. 23 in offering the courses.

From that meeting, a team of three was formed to draft the Enhancement Agreement. A draft of the Enhancement Agreement will be provided to the Education and Student Services Committee within a few months.

#### 3. Year Round Schooling

The Superintendent provided a brief update on the School Calendar. A retired Superintendent is currently researching year round schooling. The Superintendent recommended that the committee review the findings of this report once it is published.
