The Powderhound's Friday Adaptive Ski School at Big White Ski Resort offers unique skiing, sit skiing and snowboarding opportunities for students in Central Okanagan Public Schools with physical, cognitive, and sensory challenges. Powderhounds has certified volunteer instructors who are trained to use adaptive ski equipment and provide adapted ski instruction. Inclusive Education Services staff facilitate the Powderhounds Friday Adaptive Ski School Program. A student's multi-disciplinary team may include the following: Physical Therapist, Resource Teacher, Vision Resource Teacher, and Hearing Resource Teacher. After students have participated in their single lesson in the Powderhounds Friday Adaptive Ski School Program, families can pursue skiing for their child by registering with People In Motion in conjunction

with the Powderhounds Adaptive Snow Sports Program. Whether the students are Upright Skiers, Sit Skiers, or Snowboarders, the team of Powderhounds volunteers is prepared to "see the ability" and adapt to the student's needs. The Powderhounds Friday Adaptive Ski School Program runs from January through March.

PUBLIC QUESTION/COMMENT PERIOD

Karen Stokes: Ms. Stokes took issue with public comments from Trustee Broughton regarding the issue of the getawake.ca billboard on the Westside and made comments regarding SOGI and what is taught in schools.

Trustee Broughton replied to state that children are not exposed to pornographic material in schools.

Linda Dueck: Ms. Dueck, a grandmother of three students in School District No. 23, asked for an update to her request regarding access to public board correspondence. Ms. Dueck also asked when the Sexual Health Education program is being updated and when it would be available for review.

District staff will provide the information requested.

Lorna Dieleman: Ms. Dieleman, acknowledged Pink Shirt/Anti-Bullying Day. As a grandmother of a student in School District No. 23, she asked whether there are documented statistics on whether the District has been successful on stopping bullying, whether there are student-led initiatives and relationship building programs (i.e., kindness clubs) that keep this effort going all year, and what are the expenses to participate in this day.

District staff will provide the information requested.

TRUSTEE QUERIES/COMMENTS

Trustee Fraser acknowledged Pink Shirt Day and encouraged people of all ages to stand up against bullying in all of its forms.

Trustee Geistlinger queried the process of asbestos removal in schools when it was deemed as necessary.

The Secretary-Treasurer/CFO advised that this work would always be undertaken outside of regular school hours by a qualified contractor in accordance with provincial regulations. Notification to staff and parents would occur if necessary.

Trustee Geistlinger advised that there is a Sexual Health Education Level 1 Review coming up, which is led by staff. If any students or parents have questions they can email Trustee Geistlinger or Assistant Superintendent Alan Lalonde or come to the Education and Student Services Committee meeting on April 19, 2023.

Trustee Broughton felt it was necessary to respond to Ms. Stokes' earlier comments and wanted to emphasize that transgender and gender-diverse students are real and often not accepted at home. For many, it is up to the child to decide where they feel safe. There is violence against trans kids and the suicide rate is substantially higher unless they have a supportive parent. It is important to educate people on the diversity of humanity. Regarding the concern about Sexual Health taught in schools, a reminder to parents that they can withdraw their child from these lessons.

The Board Chair, Trustees and Deputy Superintendent of Schools spoke of the following:

- Attendance at various Harmony Day events and assemblies, the RCMP/WFN vs Constable Neil Bruce Middle School basketball teams, the École Kelowna Secondary School and Mount Boucherie Secondary School concerts, the First Lego League "Superpowered" Regional Qualifying Tournament and the Springvalley Elementary School Community Student Learning Conversation.
- The annual Boys and Girls Club Okanagan Pink Shirt Day Breakfast returned to in-person and was held the morning of February 22, 2023 at the Laurel Packinghouse. Trustees, senior staff, and students heard from retired NHL player, Aaron Volpatti, who shared his story of perseverance.
- Students and staff throughout the District celebrated the 16th Annual Harmony Day on Wednesday, February 15, 2023, celebrating diversity, equity and inclusion. Guest speaker, Ian Tyson, spoke to an audience of over 1800 grade five students, emphasizing the importance of being grateful, kind and caring to others and building resilience to keep going no matter what obstacles come their way. Recyclable Harmony Day bags were designed by a class of artists at École Kelowna Secondary School and were distributed throughout the District.
- On Friday, February 17, 2023, the Central Okanagan Teachers' Association (COTA) and CUPE Local 3523 held their professional development days. The theme of COTA's six-District

Professional Development Conference was "Converting to What Counts" and included a math symposium. CUPE members engaged in a variety of timely and responsive learning options that promote equity and inclusion. The Central Okanagan Principals' and Vice-Principals' Association (COPVPA) also participated in professional learning sessions, focusing on learning priorities within the District's Strategic Plan.
