RECOGNITION/PRESENTATION/DELEGATIONS

Presentation: School Opening Report – Part 1

- Presenter: Hugh Gloster, Superintendent of Schools

As schools have not opened, the School Opening Report will be presented to the Board at a future Public Board Meeting. The Superintendent advised Trustees that approximately 115 students have attended secondary schools for timetable changes in the past two weeks.

PUBLIC QUESTION/COMMENT PERIOD

The purpose of this public question/comment period is to provide an opportunity to members of the gallery to ask a question or comment on any items on the agenda. The total time for this period shall normally be 15 minutes. A person wishing to speak is requested by the Chairperson of the Board to state his/her name and provide, if possible, a written copy of the comments.

Rupert Gruen, retired teacher, Shelley Courtney, parent, and Clive Gilbert, retired teacher, provided comments to the Board regarding the ongoing BCTF Labour Dispute.

Susan Bauhart, COTA President, reaffirmed the comments of the three speakers and requested that Trustees "stand up and speak" to end the current labour dispute.

The Board Chair thanked the speakers and provided an outline of previous Board actions concerning the labour dispute and the chronic underfunding of public education. Members of the public were encouraged to view the letters written by the Board which have been posted to the District's website.

TRUSTEES QUERIES/COMMENTS

Trustee Gorman

Requested an update on the challenges created by the labour dispute on the District's two major capital projects, the new Mar Jok Elementary School and the Okanagan Mission Secondary School Addition.

The Secretary-Treasurer responded that Mar Jok Elementary School is student ready. The majority of the work was completed by the end of August. The Okanagan Mission Secondary School Addition is behind schedule with substantial completion scheduled for September 12th. A significant amount of deficiencies have yet to be completed.

Trustee Fraser

Queried how student waitlists will be dealt with once school is back in session.

The Superintendent advised that student waitlists will be addressed once the actual number of students who have moved into the District and those that have left the District are determined, and that Board policy will be followed with regard to student registration priority.

Trustee Brinkerhoff

Advised the Board that the Kelowna Veendam Sister City Association will be sending a contingent of representatives to Veendam in May 2015 to attend a celebration marking the 70th anniversary of the end of the war. The Association has extended an invitation for a Board delegate to accompany the group.

Trustee Butler

Requested an update on how the labour dispute is affecting students registered in dual credit programs.

The Superintendent responded that dual credit programs normally scheduled at School District sites are not taking place. Those programs that regularly take place offsite, i.e. Okanagan College, are proceeding with District management staff liaising with the students and agencies. Students engaged in these programs receive high school credits as well as post-secondary credits.

Trustee Baxter

Recognized that September 10th is World Suicide Prevention Day. The community and the School District have programs in place regarding youth mental health; however, there is a continual need for the growth of more programs focusing on the mental health of young people.

INFORMATION ITEMS

Superintendent's Emergent Issues

Canadian Student Leadership Conference – September 23 to 27, 2014

- Approximately 800 students/teachers will be arriving from across Canada to attend the conference.
- The District made a commitment over two years ago to host this national conference and a committee of over 200 people have been involved in planning for the arrival of the students and staff.
- A significant financial commitment has been made by those planning on attending the conference, i.e. airfare, hotels and registration costs.
- The Central Okanagan Teachers' Association (COTA) has been asked to voluntarily give relief to picketing to allow access to the District's bus fleet and to Kelowna Secondary School, which was originally designated as the host site for the conference. The COTA has indicated that this was not something that would be supported.
- A letter will be sent to Jim Iker, BCTF President, requesting relief to picketing for access to the bus fleet and Kelowna Secondary School. An expedited reply will be requested in order to allow for alternate planning depending on the BCTF decision.
- Every effort is being made to move conference venues to non-School District sites, i.e. Prospera Place, City Park, or the Penticton Trade and Convention Centre. These sites will be rented at an additional cost to the School District. All additional costs will ultimately be covered by the Canadian Student Leadership Association.

Reporting Expectations for Strike Savings

For the month of June, school districts were required to report strike savings for the timeframe where there was a withdrawal of teacher services. Savings were recognized as teacher payroll and teacher benefit costs. 80% of those funds were clawed back by the government. The government has now expanded reporting requirements and is requesting a report on savings including teacher payroll and benefits, dues and fees, rentals, staff replacement costs, support staff savings, utilities, facilities and transportation. This may result in a higher percentage of savings being required to be returned to the government.
