RECOGNITION/PRESENTATION/DELEGATIONS

Welcoming New Immigrants

Violeta Malfair, Director of Instruction – Settlement Services and International Education, presented the changing composition of students in Central Okanagan Public Schools. The Welcome Centre collects and verifies all documents of newcomer students who are not Canadian and immigrants who are refugees, temporary residents, and permanent residents, as well as assists with online registration, transportation, and parent information sessions. There has been a significant increase in the number of newcomers to the District with more than 620 new students registered into 44 schools during the 2023/2024 school year, and the most common immigration status of families being Work Permit. The top countries that these newcomers have come from are the Philippines, India, and Syria followed by Ukraine, Mexico and Jamaica. The Welcome Centre currently supports 2,295 newcomer students and their families.

Update on Student Reporting

Jordan Kleckner, Director of Instruction – Learning and Innovation, provided an update on K-12 Student Reporting in Central Okanagan Public Schools. The 2022-2023 school year was a draft implementation year of the District's K-9 and Grade 10-12 Student Reporting Guidelines based upon the new Ministry Reporting Policy Framework. Province-wide implementation of the new Ministry Reporting Order occurred in the 2023-2024 school year and the new District Student Reporting process is now in place. District educators engaged in a survey about the District's Student Reporting Guidelines going into the full implementation year and changes have been made in response to the feedback. After all schools completed the first Written Learning Update of the 2023-2024 school year, families were surveyed and feedback was positive with appreciation for the written descriptive updates and resources available for parents.

DISCUSSION/ACTION ITEMS

Board/Authority Authorized (BAA) Course Proposal – Holocaust 12: Beyond the Shoah

Graeme Stacey, Teacher - École Kelowna Secondary School, and Mike Wolthuizen, Teacher, Rutland Senior Secondary School, presented the Board/Authority Authorized (BAA) course proposal for Holocaust 12: Beyond the Shoah, which is a rebranding of the 2003 course formerly known as Holocaust 12: A Blueprint for a Modern Societal Tragedy. The new proposed BAA course Holocaust 12: Beyond the Shoah provides students an opportunity to learn about Jewish life, culture, and history, both before and after the Holocaust, and to pursue deeper knowledge and understanding of their grade 10 Social Studies and prior learning. The Holocaust 12: Beyond the Shoah BAA course will ensure that survivors' stories are known, remembered, and recorded for future generations and that students' perspectives and horizons are broadened through the study of Holocaust topics that often go uncovered.

Outcome:

The Committee recommended that the Board of Education approve the Board/Authority Authorized (BAA) Course Proposal – Holocaust 12: Beyond the Shoah (École Kelowna Secondary School/Rutland Senior Secondary School), as attached to the Agenda, and as presented at the January 17, 2024 Education and Student Services Committee Meeting.

<u>Proposal for Substantive Change – Pre-Lifeguarding Academy (École Okanagan Mission</u> Secondary School)

Graham Johnson, Vice-Principal - École Okanagan Mission Secondary School, and Darryl McCrady, Teacher - École Okanagan Mission Secondary School, presented a proposal for a Pre-Lifeguarding Academy at École Okanagan Mission Secondary School. The Pre-Lifeguarding Academy enables students to build a positive self-image, maintain a fitness level required to perform aquatic rescues, learn to communicate with each other and the public, problem solve on the fly, and develop a community service mentality by using their knowledge and skills in first aid and lifesaving. Students participating in the Academy learn valuable life skills to gain employment and develop a career in the field of lifeguarding, or use these skills while studying and pursuing further post-secondary opportunities.

Outcome:

The Committee recommended that the Board of Education approve the Proposal for Substantive Change – Pre-Lifeguarding Academy (École Okanagan Mission Secondary School), as attached to the Agenda, and as presented at the January 17, 2024 Education and Student Services Committee Meeting.
