# **Private Travel Companies Offering Trips/Events to Graduating Students**

- Several private travel companies are offering large group, multi-school grad trips to winter and summer resort destinations.
- These trips are non-sanctioned events and there are serious concerns regarding student behaviour and safety at these destinations.
- A letter has been posted to the District's website "Letter to Parents/Guardians of Graduating Students", dated April 8, 2014, which provides more information to parents regarding these travel companies and trips offered.
