INFORMATION ITEM

Update of Contract Negotiations with BCTF

The Director of Human Resources - Labour Relations reviewed the material contained in the handout Summary of Major Events - 2011 Collective Bargaining between BCPSEA and BCTF.

On February 28, 2012 the Labour Relations Board issued an interim order regarding strike activity beyond Phase 1 which provides for an "initial expanded job action" allowing BCTF members to withdraw from all duties for a maximum of 3 consecutive instructional days (notice of not less than 2 school days must be provided). BCTF members will not picket, block or restrict access to schools.

Information was provided on Bill 22 - The Education Improvement Act which would suspend all strike and lockout activities, and allows for a cooling off period for both parties until August 31, 2012. Mediation would be provided to assist the parties in reaching a negotiated settlement. The net zero mandate remains in effect for any mediation process. Based on information received to date, legislative approval of Bill 22 could be completed by Tuesday, March 6th at the earliest. Trustees discussed the process should mediation prove unsuccessful in reaching a negotiated settlement.

Bill 22 also deals with a Learning Improvement Fund, collective bargaining on class size and related matters, class size limits and compensation, and consultation on class organization. Trustees discussed the procedure for allocation of the Learning Improvement Funds.

E-mail from Alice Rees, President - COTA

The Chair reviewed the information contained within the E-mail from the COTA President.

PUBLIC QUESTION/COMMENT PERIOD

The purpose of this public question/comment period is to provide an opportunity to members of the gallery to ask a question or comment on any items on the agenda. The total time for this period shall normally be 15 minutes. A person wishing to speak is requested by the Chairperson of the Board to state his/her name and provide, if possible, a written copy of the comments.

Comments were received from the gallery as follows:

- Steven Kuffner, Teacher RVE
 - Requested information on Bill 22 compensation for increased class enrolment. (*The Director of Human Resources Labour Relations advised that compensation could be in the form of an increase in salary, professional development funds, additional resources or additional prep time.*)
- Alice Rees, COTA President
 - World education rankings show Canada is among the top countries with the smallest gap between high achievers and low achievers.
 - The mediator appointed by Bill 22 legislation would have strict boundaries for negotiations and have a net zero mandate to work with.
 - Requested the Board take a stand and advise the government that they are not in support of Bill 22.
- Sheila Graham, Intermediate/Middle/Secondary Literacy Teacher
 - Encouraged the Board to treat teachers with respect, as fellow partners in Education, and send the COTA President's message to the government.
- Michelle Davies, Teacher RSS
 - Bill 22 is an act of regression.
 - Urged the Board to send letters to MLAs to stand up for what is right, not what is easy.
- Kumi Nittel, Teacher RVE
 - Proud to work for the school district and would assume the Trustees would support teachers in this issue.
- Catriona Guild, Teacher CTE
 - Want to hear that the Trustees will fight the government's position.
- Joanne Gorjanc, Teacher BGE
 - Reminded Trustees that today is anti-bullying day.

- Jane Nordquist, Teacher RVE
 - Requested an explanation as to why Trustees were not supporting teachers.
- Karen Regan, Teacher BME
 - The government has left teachers powerless to negotiate and demonstrate.
 - Someone must stand up to the government and say they don't agree with treating teachers that way.
- Danielle Weill, Teacher RVE
 - The government may listen to Trustees if they stand up for teachers.
- Nicki Hokazono, Retired Teacher/Retired Board Chair
 - Previous Boards put forward motions to BCSTA asking that teachers be given the right to strike and had signed contracts re class size language.
- Darlene Zerr, Teacher RAY
 - A Trustee's job has changed as kids have changed. The government must look at these changes.

Members of the gallery requested a response to their expressed concerns.

Trustees commented on opinions expressed by the gallery.

Additional comments received from the gallery were:

- Crystal Moore, Teacher RAY
 - The public perceives Trustees as being able to take a stand, whether or not it makes a difference.
 - Trustee support of teachers would provide teachers with encouragement and the knowledge that they have the support of the Board.
- Alice Rees, COTA President
 - Trustees need to say that the Learning Improvement Act is not for Learning Improvement.
 - Teachers want to know that what they've been doing is honoured and respected.
- Robyn Cassan, Teacher PGE
 - Want to hear that teachers are worth something.
- Jane Nordquist, Teacher RVE
 - Trustees need to comment on the Act and speak to the underfunding for education and how it will impact the role of Trustees.
- Stacey Manoin, Teacher BME
 - What is happening is not a democracy and teachers need Trustees to stand up for them.
- Kim Dennis, Teacher CTE
 - Invited Trustees to come into the classroom to see what teachers do every day.
- Erin Daum, Teacher RAY
 - Trustees should not forget what it was like to be a teacher (for those who previously were teachers).
 - Asking for respect.
- Catriona Guild, Teacher CTE
 - Asking Trustees to stand up for change.
- Jim Strachan, Teacher KSS
 - Bullying is faced every day in schools; if a stand is not taken to stop bullying, it will only get worse.
 - Trustees recognize that writing a letter to the government will not change the government's standpoint; however, to do nothing gives a silent agreement.
 - Doing nothing sells out children in the classroom and sells out teachers.

- Clay McLeod, Teacher SKE
 - Within the BC Education Plan are items that teachers believe in, including the fact that
 the teacher is one of the most important elements for student progress and
 achievement.
 - A clear statement of support from Trustees in terms of writing a letter would be a statement that they are standing with teachers in the face of Bill 22.
- Lori Dawson Bedard, Teacher CPS
 - Students are complex; adding more CEAs or para professionals, who have limited training, is not providing a service to students.
- Marie-Claude Lecours, Teacher KLO
 - Would like to know that Trustees do not agree with the Minister of Education and are willing to speak up for teachers.
- Michelle Davies, Teacher RSS
 - Within the BC Education Plan it states that the plan is essential for students to learn properly.
 - Trustees need to tell the Ministry that it's not OK to take away the provisions of the teachers' contract and it is not OK to make a new law whenever they want.
- Hilde Dietzel, Teacher ASM
 - BC is going to lose its amazing teachers.
