RECOGNITION/ PRESENTATION/DELEGATIONS

"Together We Learn" Special Edition - Kelowna Capital News

The Board Chair thanked the Assistant Superintendent for leading the endeavour to craft the 20-page Special Edition which showcases many of the District's programs and events while highlighting Trustees, students and staff. The Kelowna Capital News provided 24,500 copies of the Special Edition at no cost to the District for distribution to schools.

The Assistant Superintendent commended the many team members involved in the development of the edition, in particular Donna Stathers, Principal – Glenrosa Elementary School, Michelle DesRochers, Executive Assistant, Karen Hill, Publisher – Kelowna Capital News, and the Kelowna Capital News staff.

The Board of Education agreed to send a letter thanking all those involved in the project.

A second edition for May 2016 is being discussed with the Kelowna Capital News. This edition would highlight the District's graduating students.

Presentation: "Inside 23"

The Superintendent of Schools/CEO provided information on the "Inside 23" permanent addition to the agenda which will provide opportunities at Public Board Meetings to showcase both students and staff whose work and learning make School District No. 23 a safe, inclusive, learning community focused on success for each learner.

CUPE Local 3523

Wendy Johnson, CUPE President, and Treena Harley, CUPE Recording Secretary, provided information on "CUPE Connection" which is a local CUPE newsletter distributed on a quarterly basis. The first issue of the newsletter won the Provincial Communications Award at the 2015 CUPE National Convention for an innovative approach to communicating to members.

International Education Program

Rick Oliver, Director of Instruction K-12, provided background information on the International Education Program. There are approximately 800 new immigrant students (from 61 countries), 400 international students, and 370 English Language Learners attending schools in the Central Okanagan School District. The Board was provided with the opportunity to view a promotional video prepared by the International Education Department.

The Federal Government provides funding for two Settlement Workers in Schools (SWIS), Donna Garbelya and Carol Davidson, who work with new immigrant families, providing support to students in schools and assistance to families as they settle into their new community.

Donna Garbelya provided information on the various ways families are assisted, and introduced parent Lily Qin, who shared her story and expressed her appreciation for the support that she and her family received when they moved to the Central Okanagan.

The COPAC Representative commented that parents are receiving mixed responses from school principals regarding the process for having students opt out of taking the Foundation Skills Assessment (FSA) Exams for grades 4 and 7.

The Superintendent of Schools/CEO responded that parents are welcome to contact either the Director of Instruction for their school or the school board office for clarification on opting out of FSAs. This topic will be discussed at the January 19th Superintendent's Meeting to ensure that FSA information provided to parents is consistent District-wide.

Superintendent's Emergent Issues

Special Hiring Exemption Approved by the BC Human Rights Tribunal

- A five-year hiring exemption has been approved by the BC Human Rights Tribunal.
- The exemption is for the hiring of two Youth and Family Support Workers and a part-time Exempt Staff Manager to oversee the Support Workers.
- The successful applicants for the three positions will have an Aboriginal cultural background and an understanding of indigenous ways.

February 9th District Non-Instructional Day

- A joint letter written by the Superintendent of Schools/CEO, the COTA President, and the COPVPA President, has been sent to teachers, Principals and Vice-Principals, and Senior Educational Staff, providing information on the Non-Instructional Day.
- The day's activities are being planned through the Joint Educational Change Committee, and it is anticipated that there will be over 1,500 attendees and 58 teacher/facilitators focusing on the K-9 redesigned curriculum and the K-12 learner competencies.

The COTA President commended those involved in planning the Non-Instructional Day.

Principals and Vice-Principals – Approved Compensation Increase (December 14, 2015)
