# **Trustee Fraser**

Queried whether any updates had been received with regard to the Education Minister's comment that BC schools will become innovation schools, and if any schools in the Central Okanagan School District have been chosen to become an innovation school.

The Superintendent responded that this political announcement was part of an innovation forum focusing on re-energizing education in the province. It has been announced that potential grant funding would be provided to school districts who partner with post-secondary institutions around innovation. No more information has been received to date.
