PRESENTATION

Continuity of Educational Opportunities

Jon Rever, Assistant Superintendent; Jamie Robinson, District Principal - Leadership in Learning and Innovation; and Jordan Kleckner, District Principal - Learning Technology, presented the Together We Learn Continuity of Educational Opportunities website. The website was designed in collaboration with the District's various consultant departments and members of the senior education team in response to the current pandemic and the need to support remote instruction and continued learning at home. Digital resources and the District's Together We Learn newsletters on the District website provide educators with opportunities to network with each other as well as create and share learning resources.

Students are encouraged to apply strategies for healthy living, increase their knowledge and skills in the sport of basketball, practice sportsmanship, play basketball outside of school time, and be positive role models and representatives of École KLO Middle School. The Basketball Academy is an equity-based program where all ability levels and students are welcome.
