Thank you for your response. Can you confirm with me that the allocated budget for school district 23 includes the budget for the five Executives that are currently taking a 1.4 million dollar annual compensation package?

As well I am curious to know how the children in Vernon British Columbia are able to take the bus at \$80 annually but Kelowna children have to pay 600 if this increase is approved?

Cornell British Columbia has zero fees to get their children to school on the bus. All of these towns are in British Columbia.

The Board has received your emails dated February 18 and 20, 2025.

While the \$75 transportation (busing) increase per student is not minor, and will certainly be a noticeable budget item for families who enroll in this service, it unfortunately doesn't come close to paying for the costs associated with busing in our district. The provincial government grants our school district \$600,000 each year to contribute towards transportation/busing costs. In addition to the fees collected from parents, the district *still* has had to take approximately 4.4 million dollars out of the operating budget to cover the remaining costs of busing. That money, if not spent on busing, would be going directly into classroom supports (teachers, CEAs, etc.).

Trustees agree that increased funding dedicated to transportation in our school district would be greatly appreciated. If you wish to advocate for increased funding from the Ministry of Education and Child Care, please feel free to contact them with your concerns. We appreciate when parents add to our advocacy efforts!

Additionally, for the purposes of clarification, Central Okanagan Public Schools trustees get an average stipend of \$24,021 per year. (Page 55 of our Statement of Financial Information: https://www.sd23.bc.ca/documents/afe65dc0-c042-4ba6-

<u>9839-2ec72b6b464f/SOFI%20Report%20June%2030%202024.pdf</u>). You can find the wages of exempt senior staff in that report as well, and you'll find that they're comparable (on the lower end) to other similarly sized school districts in the province.
