Mr. David Bruce, presenter at the October 10, 2012 Public Board Meeting regarding a request to amend the Regional District Central Okanagan Dog Control Bylaw No. 366, Section 12, provided a statement asking Trustees to give serious consideration to changing the Bylaw to allow restricted access/times when dogs on leash could be allowed in certain areas of school grounds when children are walked to and from school.

The Board Chairperson thanked Mr. Bruce for his presentation.

# TRUSTEES QUERIES/COMMENTS

#### **Trustee Pendharkar**

Requested a correction to the Board of Education Public Meeting Minutes of September 26, 2012 regarding the "Gibson Road Sidewalks" Information Item. The request for information was for a sidewalk addition to Hartman Road, rather than Gibson Road.

The Secretary-Treasurer advised that, although the road named in the Information Memorandum was incorrectly noted as "Gibson Road", the information researched was in fact for "Hartman Road".

The Chairperson advised that a request for a review of sidewalk priorities should first be sent to the Safe Schools Committee, which has representatives from all areas of the municipality. Trustee Gorman, as Trustee Representative to the Safe Schools Committee, will take the sidewalk review request to the next meeting of the Committee.

The minutes of the September 26, 2012 Public Board Meeting will be amended to reflect the correct road name in the Information Item.

### **Trustee Fraser**

Requested clarification on the District's policies and regulations regarding the recent showing of the Amanda Todd YouTube video in several classrooms across the District.

The Superintendent responded that conflicting messages have been received from the Ministry of Education regarding the sharing of the video in classrooms around the province. The Ministry's position has changed somewhat with regard to students being shown the Amanda Todd YouTube video in their classroom. Should a District teacher wish to show the video to their class, discussion must first occur with school administration and district senior staff (including the Director of Instruction, Student Support Services), and parental permission must be received. The District's Policy 460 "Appeals Bylaw" and 460.1R (Regulations) "Appeals Related to Instructional Resource Materials and Library Resource Centre Material", offer an opportunity for parents/guardians to appeal the use of any classroom resource.

**Board Letter to the Minister of Education Regarding the Provincial Three-Year Commitment** to the Learning Improvement Fund

THAT: The Board of Education write a letter to the Minister of Education advising that the Learning Improvement Funds for this year have been received and dispersed to support the learning of students in the School District, and thanking the Minister for the provincial three-year commitment to providing Learning Improvement Funds to school districts.

Trustees discussed the need to ensure that the provincial three-year commitment to distribution of the Learning Improvement Fund is emphasized, as the District's program and staff components of the funds have been committed for three years.

Mr. Bruce also queried whether it was necessary for the Board to lobby for an amendment, or whether the Regional District would simply amend the Bylaw at the Board's request.

The Chairperson responded that the Board had made the decision that no move would be made to amend the Bylaw, and enforcement of the Bylaw would be in the hands of the Central Okanagan Regional District.

# **Long Term Facility Plan Public Consultation Meetings - Update**

- Two Public Consultation Meetings have been held (Westside and Central Kelowna), with the third meeting in Lake Country scheduled for Thursday, October 25<sup>th</sup>.
- ThoughtStream links are being added to the website for Westside and Central Kelowna community feedback. An additional link will be added following the Lake Country Public Consultation Meeting.
- Feedback gathered will help to guide the Board in its final decisions regarding the Long Term Facility Plan. Final approval of the Plan will take place prior to the Winter Break.

### Bill 22 - Update

- The District continues to be responsible for reporting out on class composition (e.g. where CEA support staff have been placed, or the number of gifted students or English language learners in each class) on a class-by-class, school-by-school basis.

### **Learning Improvement Fund - Update**

- A brief review of the distribution of the money received by the District through the Learning Improvement Fund was provided.
- 12.5% of the fund has been allocated to increasing CUPE CEA support staff roles.
- In a two-step process, 50% of the remaining funds were allocated toward enhancing the staffing levels in classrooms, and improving the allocation of teaching staff to class size ratio. Schools were then invited to apply for funding through criteria developed at the District level. Resources were allocated based on specific needs.

The COPAC President requested further clarification regarding resources allocated.

### We Day

- 550 students and 49 chaperones attended this year's We Day event in Vancouver on October 18<sup>th</sup>. All those involved in the organization of the District's attendance at this event were thanked for their efforts.

Trustee Fraser, Chairperson of the Education and Student Services Committee, provided a brief background on the 2012 Early Learning Initiatives Report. Further information was provided by the Director of Instruction K-12 responsible for the District's Early Learning initiatives.

Trustee Fraser, Chairperson of the Education and Student Services Committee, provided a brief review of the 2011/2012 Family Life Program Annual Report.
