#### WELCOME

Al Lalonde welcomed everyone to the Central Okanagan Committee for Safe Schools and everyone introduced themselves.

Al introduced presenter Kristi Field, School-Based Drug & Alcohol Prevention Counsellor, A.R.C. Programs. Ltd.

#### **PRESENTATION**

Kristi Field, School-Based Drug & Alcohol Prevention Counsellor, ARC Programs Ltd., shared that she works in the Changes Program with drug and alcohol counselling (specifically targeted prevention & early intervention at the Middle Schools). She also works in the Learning Centers and provides individual group counselling for students that are at-risk or beginning to show risk.

Kristi also shared that A.R.C. Programs Ltd. has mental health counselling at Mount Boucherie Secondary, Kelowna Secondary & Rutland Senior Secondary as well as in two elementary schools; South Rutland Elementary and Raymer Elementary. They have elementary school support workers to provide support for counsellors at Chief Tomat Elementary, Hudson Road Elementary, George Pringle Elementary, Casorso Elementary & North Glenmore Elementary. Currently there are three counsellors in the program that provide the following services:

- Positive Alternative to Suspension Series
- Targeted Prevention/Early Intervention (Kristi Field)
- Addictions counselling
- Community & school-based education

Kristi explained that A.R.C. Programs Ltd. engages students through using the 'Stages of Change' – Motivational Interviewing & Harm Reduction as well as focuses on educating students in order to build students' resilience.

Kristi outlined the biggest trends in drug & alcohol use (based on the referrals A.R.C. receives) and confirmed that A.R.C. Programs Ltd. is documenting this information.

• Shared that there is a D.A.R.E. graduation at Anne McClymont Elementary this afternoon and emphasized the importance of D.A.R.E., especially at the grade 5 level. She also mentioned that her recent open forum classes (Q & A period) at Central was very successful and recommended that 'open forum' discussions continue.

## Lori Holland (Crime Stoppers)

 Shared that Crime Stoppers participated in Law Day at the Kelowna Courthouse on April 21, 2018 and the event was well attended.

## <u>Lori Dawson-Bedard (COTA – First Vice- President)</u>

 Shared that at the BCSTA AGM in Vancouver last week there was a presentation on Wellness and he would like to see that continue for students and staff in our community.

 Shared that the City of Kelowna has approved 4 new bylaw officers and recognizes the need for more RCMP officers in Kelowna. The next elected City Council will determine the number of RCMP officers they approve.

### Moyra Baxter (School Trustee and Board Chair)

 Shared that SOGI 1 2 3 (Sexual Orientation and Gender Identity) is about inclusion and providing safe schools for all students. She anticipates that there might be a lot of parent/community opposition about SOGI 1 2 3 and the District needs to ensure that parents and the community know that SOGI 1 2 3 is not a curriculum and parents can't opt out of this initiative.
