## **Discussion/Action Items**

# 1. Trustee Indemnity for the 2016/2017 Fiscal Year

The Secretary-Treasurer outlined his report and noted that, as set out in the *School Act*, the Trustee Indemnity must be set each year.

#### **Outcome**

The Committee recommended that the Board of Education approve setting the Trustee Indemnity at the current rate for the period effective July 1, 2016 to June 30, 2017.

## 2. Distribution of Administrative Savings

The Superintendent of Schools/CEO advised that input had been received from some of the District's partner groups regarding the Central Okanagan School District's portion of the Ministry of Education's \$25 million re-allocation of administrative savings. Although the \$967,983 will assist in alleviating some cost pressures, the District's budget shortfall for the 2016/2017 school year is still over \$2 million. The Committee reviewed the details pertaining to application of the surplus. The Superintendent of Schools/CEO confirmed that \$30,000 of the budget for District Instructional Support and the Instructional Leadership Program will be directed towards supporting the early intervention project.

In response to a query from the COTA President, the Superintendent of Schools/CEO confirmed that there will be ongoing staffing conversations pertaining to the reduction in funding to schools which will address budget pressures in not only middle and secondary schools, but elementary as well. The CUPE Vice-President addressed the restructuring of custodial services and the Superintendent of Schools/CEO confirmed discussions will take place regarding how services and resources are being delivered to the schools before the exact model is decided upon.

#### **Outcome**

The Committee recommended that the Board of Education approve the recommendations for the distribution of \$967,983.

#### 3. 2016/2017 Annual Budget Bylaw

The Director of Finance reviewed the budget and noted that due to the re-allocation of funding discussed previously, the 2016/2017 budget will need to be revised. The Committee discussed the process that had taken place regarding the re-allocation of funds by the Ministry of Education, the ongoing budget pressures and ensuring that the public record reflects the difficulties this has placed on students, employees and schools.

#### **Outcome**

The Committee recommended that the Board of Education approve a \$5,000 grant to Kelowna Museums and a \$5,000 grant to the Kelowna Art Gallery for the 2016/2017 school year.

The Committee recommended that the Board of Education give first, second and third readings to the School District No. 23 (Central Okanagan) Annual Budget Bylaw for the Fiscal Year 2016/2017 in the amount of \$228,650,340 and that the School District No. 23 (Central Okanagan) Annual Budget Bylaw for the Fiscal Year 2016/2017 in the amount of \$228,650,340 be read a first, second and third time, passed and adopted on the 22<sup>nd</sup> day of June 2016.

#### **Information Items**

## 1. Joint Use Agreement Renewals

The Director of Finance advised the Joint Use Agreements with the City of Kelowna to support community programs at three schools (Bankhead Elementary, South Kelowna Elementary and Watson Road Elementary) are being renewed for another five-year term of 2015-2020. There have been no substantive changes to the agreements.

#### 2. 2016/2017 Administrative Savings Report

The Director of Finance outlined the components of the report noting that in order to simplify the reporting process for future years, the identified initiatives have been reduced to one, the International Education program. Discussions with the Ministry of Education staff have confirmed the one initiative meets all reporting requirements.

## **Items Requiring Special Mention**

The Assistant Superintendent noted that the targeted funding for the Aboriginal Education Council (AEC) was reviewed over the course of numerous meetings by an Advisory Committee. All of the recommendations pertaining to the projected \$3,130,849 budget were recently unanimously approved by the AEC. As a result the AEC will now be moving forward over the summer months with staffing.
