### 2. Appointment of Scrutineers

# 5. Banking Authorization

The statutory bank authority forms be duly executed, naming the Chair or alternately the Vice-Chair, jointly with the Secretary-Treasurer/CFO or alternately the Assistant Secretary-Treasurer, as signing officers for the Board of Education, School District No. 23 (Central Okanagan).

#### 6. Authorization to Conduct Official Business

The Superintendent of Schools/CEO or the Secretary-Treasurer/CFO, in the event of a critical situation that requires expedient action, be authorized to transact financial business for and on behalf of the Board of Education.

# 7. Authorization for Temporary Borrowing (Annual Line of Credit)

In accordance with the provisions of Section 139 of the School Act, the Board of Education of School District No. 23 (Central Okanagan), effective January 1, 2023 to December 31, 2023, authorize the Secretary-Treasurer/CFO to arrange for a borrowing line and credit of an amount not to exceed \$5,000,000 to meet current operating and debt services expenditures, but all money so borrowed shall be repaid not later than six months from the date of borrowing.
