TRUSTEES QUERIES/COMMENTS

Trustee Butler

Noted that the District will be hosting a Youth Mental Health Summit – "The Fire Inside Me" on Thursday, November 5, 2015, 9:30 am -2:40 pm at Hollywood Road Education Services Room 1. Invitations for parent participation will be sent out through the Central Okanagan Parent Advisory Council.

Trustee Fraser

Queried whether, given the continuing enrolment growth in the District, consideration would be given to establishing a Summer School Program for students wishing to gain extra course credits or make up courses they are struggling with.

The Superintendent responded that a variety of summer school programs have been offered in the past, e.g. a full-fledged summer school, summer course offerings for a particular cohort group, and summer school programs offered by individual schools. The most recent model, which is consistently used, offers online options for students to complete course work.

Trustee Fraser

Provided information on a recent announcement by Deborah Holmes, Teacher, École KLO Middle School, regarding the establishment of a Dutch Friendship Garden at the school. The Dutch government has sent 100,000 tulip bulbs to Ottawa, to thank Canadians for their contributions to The Netherlands during World War II. To commemorate the 70th Anniversary of the Liberation of the Netherlands, the Dutch government has provided tulip bulbs for 140 Friendship Gardens across Canada. École KLO Middle School has received 700 red and white tulip bulbs. There will be a planting ceremony at the school on Monday, October 19th at 11:00 am. The ceremony is open to the public.

MyEducation BC - Provincial Student Demographic System

MOVED by Trustee Tiede, SECONDED by Trustee Butler,

THAT: The Board of Education send a letter to the Minister of Education outlining the many problems staff are encountering with the performance of the MyEducation BC student demographic system which was implemented over the summer months.

The Board discussed the significant cost for extra time as staff work to complete their required day-to-day tasks, often outside the regular school day in an attempt to work with the system when fewer users are logged in and response time is swifter. The Ministry is aware of the performance problems being experienced with MyEducation BC, however has advised that there will be no additional funding to compensate school districts for overtime incurred by staff.

Traffic Calming via Roundabouts on Webber Road, West Kelowna

The City of West Kelowna has installed two roundabouts as well as road narrowing medians on Webber Road as a result of a large amount of complaints received regarding the speed of traffic on the road. These traffic calming measures have significantly reduced traffic speed on Webber Road near Glenrosa Elementary School.

PUBLIC QUESTION/COMMENT PERIOD

This public question/comment period is to provide an opportunity to members of the gallery to ask a question or comment on any matter pertaining to public education.

Vivian Evans, COPAC Representative, thanked the Board for their positive action concerning the problems being experienced with MyEducation BC, and queried whether overtime costs could be recovered from the product supplier, rather than being drained out of school/district budgets.

The Secretary-Treasurer responded that the product supplier is contracted by the Ministry of Education and school districts in turn are charged by the Ministry to access the software. School Districts are not able to connect directly with the supplier.

Susan Bauhart, COTA President, commented on the stress experienced by staff and the extra costs being incurred by schools for staff overtime due to the ongoing problems being experienced with MyEducation BC, and queried whether the costs for staff overtime could be taken from the District's budget rather than further straining school budgets.

The Superintendent responded that school budgets are constantly monitored by the Director of Finance to ensure that a single school is not left in an untenable position with having to fund extra costs. In such a situation, the school's budget would be adjusted.

Trustee Mossman, Chair of the Finance and Legal Committee, advised that this item would be discussed at the November 18th meeting of the Finance and Legal Committee.

INFORMATION ITEMS

Superintendent's Emergent Issues

Ministry of Education New Curriculum and Provincially-Mandated Competencies – Release Time

- In August 2015, the Ministry of Education provided the timelines for the implementation of the new curriculum and provincially-mandated competencies being phased in beginning September 2016.
- On September 28, 2015, the Ministry announced that a 10 hour allocation (two school days) would be provided as release time for staff to prepare for the new curriculum and provincially-mandated competencies being implemented.
- Senior staff have met with members of the Central Okanagan Teachers' Association (COTA) Executive regarding the release time being provided by the Ministry, which is in addition to early dismissal days already set in school calendars for the year.

- The Superintendent will be sending a letter to schools for distribution to the school community giving advance notice that there will be changes to the current school calendar once the dates/times have been set for the additional 10 hour allocation of release time.
- More information will be provided in November once the Ministry of Education releases its provincial framework.
