#### Report/Matters Arising

The June 7, 2017 General Affairs Committee Public Meeting Report was received as presented.

## **Discussion/Action Items**

#### 1. Reconfiguration Trigger Points for Families of Schools

The Board of Education has committed to working toward the implementation of the Long-Term Facility Plan which includes the move to a common grade reconfiguration when conditions support the change in each area of the School District. The desired grade reconfiguration for schools being: Elementary K-5; Middle 6-8, and Secondary 9-12 across the District. Schools in the Rutland area were reconfigured in September of 2015 to the preferred configuration. The Superintendent reviewed in his presentation to the Committee the proposed Reconfiguration Timeline for each area:

Rutland Completed in 2015

Okanagan Mission September 2019 (upon the opening of the new Middle School)

Lake Country Opening of new Lake Country Middle School

North Central Kelowna Opening of new Glenmore Secondary South Central Kelowna Opening of new Glenmore Secondary

Westside September 2018

Due to the increased enrolment pressures at elementary schools on the Westside over the past three years, a consultant was hired to conduct an enrolment study of the Westside to look at options available to the School District to respond to these pressures. The recommendation of staff to the General Affairs Committee is for a staged reconfiguration:

Elementary K-5

Constable Neil Bruce Middle 6-8

Glenrosa Middle 6-9

Mount Boucherie Secondary 9-12

The recommendation for the staged reconfiguration is to make use of the available space at Glenrosa Middle School and reduce the portable pressures at Mount Boucherie Secondary and Westside elementary schools.

The enrolment for all schools on the Westside was presented – current and projected.

On January 31st the Board of Education approved the following regarding French Immersion on the Westside:

THAT: The Board of Education support a K-12 French Immersion program on the Westside.

THAT: The Board of Education support a late entry Middle School French Immersion (6-8) Learning Community Program to be located at Glenrosa Middle School starting September 2019 (Option C);

AND THAT: École George Pringle Elementary School will be the French Immersion early entry feeder school to Glenrosa Middle School.

THAT: The location of a secondary French Immersion program in West Kelowna be determined upon completion of the proposed Capital Projects related to the Westside Area Study.

The allocation of portables at Westside schools was reviewed, along with the possible number of total portables required for the reconfiguration, subject to local government approval and building code requirements. The costs of the three options: status quo; reconfigure, reconfigure in stages was reviewed. The costs of a new portable is \$180,000 - \$200,000 installed. The more affordable option is to reconfigure in stages.

- Portable situation at Rose Valley Elementary overcrowding has contributed to minimizing access to physical education programs and washrooms
- Concern of only three days' notice of meeting
- Maturity of grade 9 students to be placed with grade 12 students at Mount Boucherie Secondary
- Safety of portables
- Teachers' reaction to reconfiguration
- Mount Boucherie Secondary already at capacity
- Impact on electives/sports teams at Mount Boucherie Secondary
- Additional portables being added to the Mount Boucherie Secondary site
- Maturity/responsibility of Grade 6 students in middle school format
- Transition of students from elementary to middle
- Communication to parents about reconfiguration
- Implementation date of 2018 move to 2019 to provide additional time to prepare students for transitions
- Arrival of grade 9 students from Glenrosa Middle to Mount Boucherie Secondary
- Transition of students when Rutland area students went through reconfiguration
- French Immersion at Glenrosa Middle
