#### RECOGNITION/PRESENTATION/DELEGATIONS

#### Mar Jok Elementary School - Update

Todd Dust, Renaissance - GHMA Architects, Inc., provided an overview of the key features and building design for Mar Jok Elementary School. The two-story building is designed to accommodate 450 students, with 19 classrooms and a Neighbourhoods of Learning component, and will provide a 21<sup>st</sup> Century learning environment.

Sawchuck Developments Co. Ltd, the low bidder on the project, has agreed to project completion by June 7, 2014, which will allow sufficient time for any deficiencies to be addressed prior to building occupancy. The alternative bid price included in the tender will also allow for an upgrade to the front wall system.

The building and landscaping are being designed to meet the equivalent for LEEDS (Leadership in Energy and Environmental Design) gold standards.

The School District has provided the District of West Kelowna with a draft of the Neighbourhoods of Learning Joint-Use Agreement and is awaiting feedback.

## Tender Award - Project No. 115780 - Construction of Mar Jok Elementary School

THAT: The Board of Education authorize the award of contract to Sawchuck Developments Co. Ltd. in the amount of \$10,767,464.00 plus GST, for the completion of Project No. 115780: Construction of Mar Jok Elementary School.

Trustees discussed options should construction not be completed by the agreed-upon date. The District has a "liquidated damages" clause in place which would make the contractor responsible for any District costs incurred should the building not be ready for occupancy by the date agreed, e.g. communication and extra busing.
