RECOGNITION/ PRESENTATION/DELEGATIONS

KSS Girls' AAAA Volleyball Team

The Board congratulated Coach Tony Sodaro, Assistant Coaches David Nault and Nikki Valgardson, and the members of the 2011 KSS AAAA Girls Volleyball Team for winning the BC Provincial Championship as well as achieving Gold at the UBC-O Best of the West Tournament, the Kelowna City Championship and Okanagan Valley Championship.

SUPERINTENDENT'S REPORT

- Three proposed policies have been forwarded to Parent Advisory Councils for review. These policies are specific to employee and student use of social media, freedom of information and protection of privacy, and child protection. Parent Advisory Councils are invited to provide input to the Board of Education prior to these policies being approved.
- Professional development and teacher learning is continuing within the district, despite current job action. Currently, project-based learning sessions are being provided to teaching staff by the Buck Institute. The February 17, 2012 Professional Development Day sessions, featuring the Kagan Group, will offer workshops focused on new strategies to increase student engagement. These sessions are being provided in partnership with the Central Okanagan Teacher's Association (C.O.T.A.).

TRUSTEES QUERIES/COMMENTS

<u>Trustee Gorman</u> provided information on a Globe and Mail article related to student use of electronic devices during a lockdown at a Vancouver school and requested information on the district's policy regarding use of electronic devices during a lockdown.

The Assistant Superintendent advised that the district's Board-approved interim social media policies for employees and students do not have a component regarding use during a lockdown situation. The district is currently awaiting Parent Advisory Council feedback for these policies. Once compiled, the feedback will be brought back to the Board of Education for consideration when policies are finalized. Once final approval has been received, network user agreements will be amended and will include language regarding electronic device use during a lockdown. The Superintendent advised that a number of protocols exist within the district regarding critical response plans.

Staff agreed to forward the Globe and Mail article to all Trustees.

Westside Road - Gravel Pit

Field Trips 2011/2012

The Secretary-Treasurer provided information regarding a field trip scheduled for George Elliot Secondary School (GESS) students to attend an Encounters Canada Program in Ottawa from February 11 - 18, 2012. The week-long event is focused on Inuit Arts and Culture and students will tour parliament, meet influential Canadians and collaborate with students from across the country. The program is subsidized by the Federal Government. GESS students were invited due to a last minute cancellation by an alternate school and the timeline between Board approval and the field trip dates does not meet Policy 525 *Field Trips* requirements.

The Board requested that this be placed as an item on the Coordinating Committee Agenda for a future presentation by students participating in the field trip.

Draft Vision and Guiding Principles for Neighbourhood Learning Centres

The Superintendent provided background information on proposed Neighbourhood Learning Centres for the new Rosewood Drive Elementary School in West Kelowna and, in future, for the OKM Secondary School expansion. The Board discussed the vision, purpose and guiding principles for the Learning Centres. The Ministry of Education will provide funding for up to a 15% expansion of the new floor space to house and operate a Learning Centre. There is a requirement for the district to have a community partner in order to have the additional space approved. School District No. 23 will approach municipalities to work in partnership in creating programs for the Learning Centres. More information and an amended guiding principles document will be provided at a later date.
