1. Board/Authority Authorized (BAA) Course Proposal - Yoga & Wellness 12

Scott McLean, Principal, and Lea Ivantiz, Teacher, from Kelowna Secondary School, presented the proposed <u>Yoga & Wellness 12</u> (Kelowna Secondary School) BAA Course. <u>Yoga & Wellness 12</u> offers students a deeper understanding of the practice and principles of Yoga. This course is complimentary to those who have taken Yoga and Fitness 11; however, it will also be available to students who have not taken Yoga and Fitness 11, but who have a background in Yoga as demonstrated to the teacher through a physical demonstration as well as dialogue to ensure a foundational understanding of Yoga principles and movements.
