PUBLIC QUESTION/COMMENT PERIOD

There were no public questions/comments.

COMMITTEE MEMBERS QUERIES/COMMENTS

Trustee Fraser requested clarification regarding bus pick-up times for secondary students.

The Secretary-Treasurer/CFO stated that in order to accommodate the District's Return to School Plan, noon hour busing will be provided to Kelowna Secondary and Mount Boucherie Secondary students. Noon hour busing couldn't be provided to all secondary schools due to limited resources. Secondary students who ride the bus and attend either George Elliot Secondary, Rutland Secondary or OKM Secondary will be accommodated to stay at the school until the regular afternoon bus run.

DISCUSSION/ACTION ITEMS

Right-of-Way for Inverness Road Dedication on Former Webber Road Elementary School Site

The Director of Operations outlined the request from Kerr Properties for the School District to dedicate a portion of land on the former Webber Road Elementary school site in exchange for Kerr Properties to construct the full Inverness Road extension, storm sewer upgrade and a multiuse pathway. The Right-of-Way extension would have been required when the School District developed the former Webber Road Elementary site. As it is unclear as to when the School District may be in a position to develop these lands, it is recommended to authorize Kerr Properties to undertake the land dedication process with the City of West Kelowna. The land will be dedicated to the City of West Kelowna and future maintenance and upgrade costs required for the multi-use pathway will not be the responsibility of the District. The adoption of Property Bylaw No. 151 will not impact the development of any proposed school facility on this site.

Outcome:

The Planning and Facilities Committee recommended the following to the Board:

THAT: The Board of Education give first, second and third readings to School District No. 23 (Central Okanagan) Property Bylaw No. 151 (as attached).

THAT: School District No. 23 (Central Okanagan) Property Bylaw No. 151 (Land Dedication) be read a first, second and third time and finally adopted;

AND THAT: The Board of Education of School District No. 23 (Central Okanagan), hereinafter called 'the Board', grant authorization to Kerr Properties to undertake

the land dedication process with the City of West Kelowna to build road upgrades and a multiuse pathway on Lot 96, DL 3481, PL 20022, ODYD.

DISCUSSION/INFORMATION ITEMS

Transportation Services Update

The Director of Operations provided an update on Transportation Services for the 2020-2021 school year highlighting that as of August 20, 2020, 5,750 applications had been processed and 4,577 students had been assigned to a bus route. He also stated that Transportation Services has moved forward with several significant process improvements as it implemented the Board's direction reflected in the recently updated Transportation policies.

The Director of Operations shared that due to Provincial guidelines for transportation during COVID-19, fewer seats could be assigned for middle and secondary students (2 per seat versus 3 per seat). He also outlined the following key items pertaining to transportation that have been included in the Central Okanagan Public Schools Staff and Safety Plan:

- Drivers are required to wear a non-medical mask, a face covering or a face shield when not able to maintain the physical distancing requirements.
- Drivers will clean buses between each run and buses will be disinfected once daily.
- Hand Sanitizer will be available on the bus for drivers and students.
- Seats inside the school bus are numbered and students will have assigned seating.
- No food or beverages permitted on the school bus (except a personal water bottle).
- No guest riders will be permitted, only registered students may ride.

The Director of Operations commended the Transportation Services staff for all their work preparing for the 2020-2021 school year.

Custodial Services Department Summer Update

The Director of Operations outlined the summer work completed by the Custodial Department including but not limited to: full top to bottom clean of all 48 sites, washing of furniture, cleaning of all dryer vents, wood shops and dust collectors as well as cleaning of building exteriors and windows.

The Director of Operations shared that extra staff have been hired to assist with the Provincial COVID-19 Health and Safety Plan, Central Okanagan Public Schools Staff and Safety Plan, and Custodial Department Policies and Procedures.

The Director of Operations commended the Custodial staff for working through the COVID-19 Safety Plans to ensure proper procedures are in place.

In response to a query from the COTA President regarding electrostatic sprayers, the Secretary-Treasurer/CFO confirmed that all safety protocols will be followed.

Operations Summer Projects Update

The Director of Operations outlined the 2020 summer work completed by Operations staff. The list of projects this year was extensive and many were complex in design; however, staff provided outstanding leadership and workmanship in achieving the completion of all the major projects within the District. There will be little or no disruption for the start of the 2020-2021 school year.

The Director of Operations and Secretary-Treasurer/CFO responded to questions from Committee members.
