## PUBLIC QUESTION/COMMENT PERIOD

This public question/comment period is to provide an opportunity to members of the gallery to ask a question or comment on any matter pertaining to public education.

Vivian Evans, COPAC Vice President, requested information on the continuation of breakfast programs provided to vulnerable students when they transition from elementary to a middle school that may not offer a breakfast program.

The Superintendent responded that, when students transition from one level to the next, teams from the school sending the students will meet with a team from the receiving school, to provide information on the students moving forward and to ensure that a plan is in place to support vulnerable students. If schools do not have a formal breakfast program, it is a common practice for office staff to maintain a stock of non-perishable foodstuffs for students who may need them.

Shelley Courtney, Glenmore Elementary Parent, requested information on the number of breakfast programs in the Central Okanagan School District.

The Superintendent responded that approximately 30 schools have formal programs. Other schools offer a variety of structures, i.e. cafeteria programs and school stores. Several outside organizations provide support for school breakfast programs and CommunityLINK funds are used to fund the Brown Bag Lunch Program.

## **Superintendent's Emergent Issues**

## **Grade Reconfiguration - Rutland Area Schools**

- Public Consultation Meetings are scheduled for the Rutland community during the week of November 17<sup>th</sup>. Meetings are scheduled for Monday, November 17<sup>th</sup> at Springvalley Middle School (for all of its feeder schools), Tuesday, November 18<sup>th</sup> at Rutland Middle School (for all of its feeder schools), and Thursday, November 20<sup>th</sup> at Rutland Senior Secondary School (for the school community). All meetings are scheduled to begin at 6:30 pm.
- The Board's Long-Term Facility Plan (approved in December 2012) acknowledges the move to consistent grade configuration in all schools, with elementary schools being K Gr. 5, middle schools being Gr. 6 Gr. 8, and secondary schools being Gr. 10 Gr. 12.
- The Consultation Meetings will be followed by an online survey. All community feedback will be gathered and reviewed, with a plan brought to the Board for a recommended timeline for the grade reconfigurations.

# Board Policy and Regulation 631 - School Closures/Consolidation

Growth in all areas will continue to be monitored.
