TRUSTEES QUERIES/COMMENTS

Trustee Fraser

Requested information regarding the recent news article in the Kelowna Daily Courier stating that the school district would be working in partnership with the City of Kelowna to develop the Parkinson Rec Centre site once approval had been received from the Ministry to build a new Glenmore Secondary School.

The Secretary-Treasurer responded that the Glenmore Secondary School Project Identification Report (PIR), approved by the Board at the September 23, 2015 Public Board Meeting, included information that staff have had initial discussions with the City of Kelowna regarding the Burtch Road site, should that be the final site chosen to build the new secondary school. The City of Kelowna Apple Bowl sits partially on school district property and the City is reviewing the possibility of rebuilding the Parkinson Rec Centre at that site as well. Numerous discussions will need to occur, as well as Ministry funding approval for the new school, prior to any agreement being reached. All agreements would ultimately require Board approval.

PUBLIC QUESTION/COMMENT PERIOD

This public question/comment period is to provide an opportunity to members of the gallery to ask a question or comment on any matter pertaining to public education.

The COPAC Representative queried where the funding for the FreshGrade software licence would be allocated from within the District's overall budget.

The Secretary-Treasurer responded that the District has an account for software and licence purchases, and if the cost was significant, the amount could be taken from local capital funds or the supplies and services account.

David Grabavac, Lake Country Parent, queried the process for distribution of community feedback received by the Board regarding the Lake Country Catchment Area Review.

The Board Chair responded that Trustees have discussed various methods for distribution of community feedback should the Board decide to distribute the additional responses received.

The Superintendent advised that all raw data will continue to be provided to the Board. It is staff's intent to provide a summary of the feedback received which could be collated several ways, e.g. by geographic location or preferred choice of Focus Group options. This information would then be provided as an attachment to the January 6, 2016 Planning and Facilities Committee Agenda. Letters have previously been sent to Lake Country families informing them of the catchment area review, the Focus Group recommended options, and the discussion of staff's recommendation(s) at the January 6th Committee Meeting. Feedback will continue to be received until a decision has been made by the Board.

David Grabavac, Lake Country Parent, requested that all proposed recommendations be made available for the community to review prior to the January 6, 2016 Planning and Facilities Committee meeting.

The Superintendent responded that staff's recommendation(s) will be posted to the website by the Winter Break (December 2015).

INFORMATION ITEMS

Superintendent's Emergent Issues

Ministry of Education Enrolment Validation Audit

- Senior staff were advised the afternoon of December 9th that the Ministry of Education would be conducting an enrolment validation audit of three schools in the Central Okanagan School District on Thursday, December 10th.
- The purpose of the audit is to conduct an enrolment check of all students with new Personal Education Numbers (PEN), as the District is seen as being fairly unique in its increased enrolment numbers compared to most school districts which have declining enrolment.
- The three auditors will be reviewing the student files for these new students to determine where they are arriving from.
- The three schools being audited are Rutland Senior Secondary School, Anne McClymont Elementary School and Constable Neil Bruce Middle School.
- The Ministry of Finance has requested that the audit be conducted prior to the distribution of recalculated enrolment funding which is normally sent out before the Winter Break.

French Immersion Task Force Steering Committee

- The next meeting of the Steering Committee is scheduled for Friday, December 11th at 9:00 am.
- The purpose of the meeting is to plan for the larger French Immersion Task Force Meeting scheduled to take place in January.

Joint Educational Change Committee (JECC)

- The next meeting of the Joint Educational Change Committee is scheduled for 12:00 noon on Friday, December 11th.
- Discussions will continue regarding the plans for supporting teachers with the re-designed curriculum.

Media Introduction to Kevin Kaardal, Superintendent/CEO Designate

- Local media have been invited to the School Board Office on Wednesday, December 16th at 1:30 pm, where the Board Chair will provide an introduction of Mr. Kaardal.

Replacement of the Ministry's Accountability Framework

- The Superintendent/CEO Designate advised that staff are in the activation stage of meeting the Ministry's requirement for school districts to plan a Framework for Enhancing Student Learning that will replace the previous accountability framework.
- The activation stage will include discussions with the Joint Educational Change Committee, and with parents at COPAC meetings to review current best practices of the District for development of the new framework for accountability.

Video Surveillance: Annual Report to the Board

The Superintendent reviewed the information contained in the Annual Report. 26 of 46 District sites are using video surveillance equipment. Video surveillance systems are used primarily as a means of identifying unwelcome visitors on school property, and to assist in ensuring that students and staff are safe and secure at school and District sites. Revisions to Board Policy 645 – *Video Surveillance Closed Circuit Television (CCTV)* will be required to ensure alignment with changes resulting from the introduction of Bill 11, and the District Human Rights Committee will be asked to provide input on revisions to the Policy as well.

Revenue and Expense Summary at October 31, 2015

The Central Okanagan School District has had a significant increase in student enrolment numbers this year which will be reflected in the Ministry's September recount and corresponding recalculated funding expected to be received in December.

September 2015 Enrolment Numbers

Staff will continue to monitor enrolment numbers, as increasing enrolment could have implications for budget planning in the future.

Field Trips 2015/2016

Staff, students and parents involved in planned international trips continue to meet and be provided with the latest federal government's travel advisory information.
