Rutland Senior Secondary School Forestry Program

Alan Kolkind, Teacher at Rutland Senior Secondary (RSS) and instructor of the Forestry Program, introduced RSS Teacher, Dustin Herbeson who is a co-instructor of the program. An overview of the dual-credit forestry program was provided and it was noted that since its inception in the late 1980s, students have gone on to achieve various certifications, degrees and fulfilling careers. A video was presented which highlighted the components of the program and which can be shown at other middle or secondary schools in order to garner interest about this potential career path.
