Information Items

1. Surplus Policy Discussion

All Boards of Education are required to discuss and approve a surplus policy that guides future years' interfund transfers and ensures that stakeholders are aware of the policy and understand what it means. The Ministry's expectation is that this policy will be developed during the 2017/2018 fiscal year and the policies will be approved by the Board of Education no later than September 30, 2018. The Assistant Secretary-Treasurer distributed and reviewed a Surplus Appropriation Analysis.

Outcome

The Finance and Audit Committee recommended a draft Surplus Policy be developed and brought back to the Finance & Audit Committee for review.

2. Budget Submission Template

The Secretary-Treasurer reviewed the Budget Submission Template with Committee members. The Template will be provided to all partner groups for completion of their budget submissions.

3. Additional Allocation to Schools

An additional \$250,000 is available, due to expected surplus monies, to be distributed to schools. The Assistant Superintendents have met with their family of schools to discuss where the need for the additional funding is. The supplemental funding is available to be used for supplies and/or extra staffing.

Items Requiring Special Mention

1. Impact of Payroll Tax

The Committee discussed requesting the Board to write a letter to the Ministry regarding the new payroll tax indicating school districts do not have the budget to pay the tax and therefore it should be funded by the Ministry, and also that school districts should not be taxed the same as businesses. The Secretary-Treasurer will provide more information on the impact of the tax on the Central Okanagan Public Schools at the next Finance and Audit Committee Meeting.
