RECOGNITION/PRESENTATION/DELEGATIONS

Authentic Parent Engagement to Enhance Student Learning

Jon Rever, Acting Deputy Superintendent of Schools, and Sue Steveson, Principal – North Glenmore Elementary School, presented the topic, Authentic Parent Engagement to Enhance Student Learning, which is connected to one of the four strategic directions within the District's Strategic Plan – Family and Community Engagement. The District Strategic Plan's four priorities and directions that guide the learning in Central Okanagan Public Schools are Equity and Excellence in Learning, System Wellbeing, Transformative Leadership, and Family and Community Engagement. The strategic direction, Family and Community Engagement, focuses on student learning and school improvement through relational trust, engaging families more often as partners in supporting their child's education, and providing families with opportunities for mutual input.

The District was invited to participate in a Brookings Institute research study about 'Collaborating to Transform and Improve Education Systems' in 2021. The research brought forward that schools with family engagement are ten times more likely to improve student learning outcomes, deep dialogue with families and schools is needed to unlock systemwide transformational processes, and communicating with families can be one of the most highly cost-effective approaches. During the last two years, North Glenmore Elementary School (NGE) has worked towards forming an effective family-school partnership with NGE parents and families around the numeracy learning of students in kindergarten to grade six. A sampling of NGE students from all classrooms were queried to hear student voice about numeracy learning, staff came together to dive deeper into numeracy resources and participate in a ThoughtExchange, families were engaged in a whole-school math challenge and a parent feedback ThoughtExchange to improve numeracy at NGE, and Numeracy learning priorities were developed for the 2024-2025 school year. The family-school engagement strategy at NGE has been effective and the school continues to work towards transforming numeracy learning for students at North Glenmore Elementary School.

DISCUSSION/ACTION ITEMS

Constable Neil Bruce Middle School - Outdoor Education Academy Fee Increase

Brad Kuhn, Principal – Constable Neil Bruce Middle School, and Mike Burdeniuk, Teacher – Constable Neil Bruce Middle School, presented the proposed fee increase for the Outdoor Education Academy at Constable Neil Bruce Middle School (CNB). The Outdoor Education Program was established at CNB in 2008 with approximately 60 students enrolled in the academy. The popularity of this program has increased since 2008 and there are approximately 152 students enrolled in the Outdoor Education Academy each year. The expenses for the program have also increased greatly since 2008 due to rising inflationary costs, the upkeep and increased costs of equipment, as well as increased expenditures for Teachers Teaching on Call and transportation. The proposed fee increase will ensure the Outdoor Education Academy at CNB is financially sustainable moving forward.

Outcome:

The Committee recommended that the Board of Education approve the proposed fee increase of \$100 (from \$125 to \$225/student) for the Outdoor Education Academy (Constable Neil Bruce Middle School), as attached to the Agenda, and as presented at the January 15, 2025 Education and Student Services Committee Meeting.

<u>Central Okanagan Public Schools Hockey Skills Academy Fee Increase (Canyon Falls Middle School, École KLO Middle School, Mount Boucherie Secondary School, École OKM Secondary School, Rutland Senior Secondary School)</u>

Graham Johnson, Vice-Principal at École Okanagan Mission Secondary School, and Blain Wright, Teacher Coordinator of the Hockey Skills Academy, presented the proposed fee increase for the Central Okanagan Public Schools Hockey Skills Academy at Canyon Falls Middle School, École KLO Middle School, Mount Boucherie Secondary School, École OKM Secondary School, and Rutland Senior Secondary School. The academy fee increases will compensate for the increase in expenses due to the rising cost of ice rental, bus transportation, and instructor wages, as well as growing inflationary costs for many aspects of the program. The proposed fee increases will make the programs financially sustainable moving forward.

Outcome:

The Committee recommended that the Board of Education approve the proposed fee increase of \$100 (from \$1300 to \$1400/student) for the Central Okanagan Public Schools Hockey Skills Academy (Canyon Falls Middle School, École KLO Middle School, and École OKM Secondary School), as attached to the Agenda, and as presented at the January 15, 2025 Education and Student Services Committee Meeting.

The Committee recommended that the Board of Education approve the proposed fee increase of \$75 (from \$1170 to \$1245/student) for the Central Okanagan Public Schools Hockey Skills Academy (Rutland Senior Secondary School), as attached to the Agenda, and as presented at the January 15, 2025 Education and Student Services Committee Meeting.

The Committee recommended that the Board of Education approve the proposed fee increase of \$35 (from \$965 to \$1000/student) for the Central Okanagan Public Schools Hockey Skills Academy (Mount Boucherie Secondary School), as attached to the Agenda, and as presented at the January 15, 2025 Education and Student Services Committee Meeting.

The Committee requested that the information regarding Parent Advisory Council Consultation be updated in the Hockey Skills Academy Fee Increase Action Memo prior to the recommendation coming forward to the Board of Education.
