### Amendments to Policy 486 – Student Use of Electronic and Social Media Communication

Amendments to Policy 486 – Student Use of Electronic and Social Media Communication were first brought forward to the Policy Committee on February 5, 2020. The amendments were suggested to reflect the evolution of the network and to bring the terminology up to date. The amendments were forwarded to partner groups for discussion. Subsequently, the District Principal – Learning Technology Programs contacted representatives from COPAC, CUPE, COTA and COPVPA to obtain feedback on the suggested amended language. All partner groups were in favour of the amendments. The Assistant Superintendent and District Principal of Learning Technology Programs responded to queries regarding the removal of item 1 under Policy. The Network Agreement will be incorporated into each School's Code of Conduct. In order to ensure standardization of the language in the Code of Conduct, wording will be provided to the schools. The Committee discussed suggested amendments brought forward by Trustee Geistlinger.
