Recognition/Presentations/Delegations

1. Mental Health and Wellness Initiatives in the Central Okanagan School District

Vianne Kintzinger, Director of Instruction (K-12), provided information on the mental health and wellness initiatives in the Central Okanagan School District. These initiatives align with the District's Health Promoting Schools' goal to educate students to be healthy, resilient, and empowered; as well as, reflect the teachings of the Medicine Wheel (Emotional, Spiritual, Physical, and Intellectual). An overview of the various supports for students, parents and guardians, employees, and school communities was provided.

1. PacificSport Okanagan - Update

Vianne Kintzinger, Director of Instruction (K-12), provided an update on the PacificSport Okanagan program. This program offers support to students attending schools within the Central Okanagan School District that are heavily involved in sports. Student athletes are enrolled in core and elective courses for a half day at their home school. The other half of their school day is spent off campus receiving personalized support with their studies and fitness training. PacificSport Okanagan is also involved in an Intermediate Physical Literacy Program, where a PacificSport instructor co-teaches with an intermediate teacher during their PE classes to focus on physical literacy games and movement skills.

Outcome

It was requested that representatives from PacificSport Okanagan update the committee on their current business plan at a future Education and Student Services Committee meeting and that senior staff conduct a review of the current program.

The Ministry of Education and the BC Teachers' Federation are scheduled to meet mid-October and will provide further updates by early November 2015.
