The District of Lake Country is working on a grant application with our Roads team for work being planned in line with [Safe and Active School Routes](#) program for active transportation improvements to connect Seaton and Camp Rd to Okanagan Centre Road East for students from these neighbourhoods heading into the town core to go to school at GESS and HS Grenda. I understand that students living in the Monte Bella Rd area are outside of the school bus service area and having improved infrastructure for walking or cycling to school safely is very important.

As part of the application requirements, a letter of support from the School Board is needed, and it is strongly encouraged to have letters of support from the principals/vice principals of the schools. We will be reaching out to the principals of HS Grenda and George Elliot individually.
