REPORTS/MATTERS ARISING

Finance and Audit Committee Public Meeting Report - January 19, 2022

It was noted that subsequent to the Finance and Audit Committee's review of the 2021/2022 Amended Budget Bylaw on January 19, 2022, an adjustment of \$13,530 was made to Statement 2, line Budgeted Allocation (Retirement) of Surplus (Deficit) to agree to the 2020/2021 audited financial statements (Schedule 2). The updated balance of \$5,902,262 represents the internally restricted amount that was appropriated as of June 30, 2021. Therefore, the revised Amended

Budget Bylaw amount, that went forward to the Board on February 9, 2022, was updated to \$302,076,449 from \$302,089,979, as stated in the Report.

PRESENTATION

2022-2023 Preliminary Budget Presentation

The Assistant Secretary-Treasurer presented an overview of the District's overarching goal, strategic directions, staffing information, student statistics, financial sources as well as assumptions and challenges that will guide the preparation of the 2022-2023 Annual Budget Bylaw. The 2022-2023 Annual Budget Presentation was also shared at the February 7, 2022 COPAC Meeting.

The Assistant Secretary-Treasurer responded to Trustee and partner group queries.

The 2022-2023 Budget Presentation and the 2021-2022 Amended Annual Budget Bylaw will be included with the 2022-2023 Budget Survey that will be sent to all partner groups, the general public via the District and school websites and parents via school messenger. The Budget survey will be distributed on February 18, 2022 with a deadline of March 4, 2022.

DISCUSSION/ACTION ITEMS

Review of Transportation Fees for the 2022/2023 Fiscal Year

The Committee Chair read the following issue statement from the memo that was attached to the Agenda:

"Although not mandated by the School Act, the Board of Education has supported the operations of a student transportation system for students in Central Okanagan Public Schools. As part of its support for transportation, the Board of Education each year must heavily subsidize the transportation department with approximately \$3.8 million in operating funds that could be directed to classroom supports and operations. Each year, the Board of Education reviews the fee that it charges for all students that receive this service."

The Secretary-Treasurer/CFO shared that with the price of fuel going up, an increased need for additional bus routes, and the anticipation of salary increases, staff are recommending a \$50 per year increase to the transportation fee.

The Secretary-Treasurer/CFO responded to questions from the Committee.

Outcome:

The Finance and Audit Committee recommended to the Board:

THAT: The Board of Education set the transportation fee to \$350/year for each bus rider for the period effective July 1, 2022 to June 30, 2023.

DISCUSSION/INFORMATION ITEMS

2022-2023 School Fees Summary

The Assistant Secretary-Treasurer stated that a summary of school fees is provided annually. School fees are divided into four categories: Standard Fees (optional school supply, cultural, student activity fees), Transportation Fees, Academy Fees, and Goods and Services Fees. As per Board approval at the January 26, 2022 Public Board Meeting, Mount Boucherie Secondary School increased fees for the Baseball Academy, Soccer Academy, and Outdoor Education Program. At Rutland Senior Secondary School, the Soccer Academy fees decreased due to increased enrolment, the Equine Academy fees decreased as per an outside financial sponsorship, and the fees for the Emergency Medical Responder Dual Credit Program went up to offset increased costs from the Justice Institute.
