RECOGNITION/PRESENTATION/DELEGATIONS

Enhancing Student Learning Framework Update

The Superintendent of Schools/CEO outlined the Continuous School Learning Improvement Planning process which includes four components: School Team reflection on the inquiry and learning described in the School Community Learning Plan, a Summary Report to the Board of Education, a Year-End Report provided by the Assistant Superintendent to the school principal, and Planning for the upcoming school year. Due to the COVID-19 pandemic, the District has not been able to complete the School Community Learning Conversations and the Annual School Community Learning Forums which is part of the planning process.

The work of Enhancing Student Learning focusses on using the Spirals of Inquiry to determine what is going on for our learners. The OECD Seven Principles of Learning and the First Peoples Principles of Learning are reflected in each school's Our Learning Story and the School Community Learning Plan. The Superintendent of Schools/CEO shared that the Government of BC is developing policy regarding Enhancing Student Learning. The School and District Enhancing Student Learning Framework will be finalized when the policy is received from the BC Ministry of Education.

Year-End Reporting Guidelines

Terry-Lee Beaudry, Deputy Superintendent of Schools, and Jamie Robinson, District Principal for Leadership in Learning and Innovation, shared the primary guidelines to guide year-end reporting and the following statement that is to be included on each summative year-end report:

"During the COVID-19 pandemic, teaching and learning has continued within a context of diverse circumstances for students, families, and educators. Teachers have used their professional judgement to determine a final grade/assessment for each student by considering the assessment data available for each learner. As a result, year-end reporting may be more heavily based on learning that was done prior to the suspension of in-class instruction."

The Year-End Reporting Guidelines and Frequently Asked Questions (FAQs) document supports the continuity of learning, was created through an inclusive process with the District Assessment/Communicating Student Learning Committee, and is in alignment with the Ministry of Education expectations and the District's Principles of Assessment Policy (506).

PUBLIC OUESTION/COMMENT PERIOD

There were no public questions/comments.

COMMITTEE MEMBERS QUERIES/COMMENTS

Trustee Bowman queried how the District is doing at educating regarding systemic racism, how many Black people, Indigenous people, and people of colour have offered curricular content that the District already teaches, and how the District could support teachers to access professional development regarding anti-racism.

Trustee Baxter shared that Systemic Racism is an agenda item on the June 24, 2020 Public Board of Education meeting.

ITEMS REQUIRING SPECIAL MENTION

<u>UBC Okanagan Social Sciences and Humanities Research Council (SSHRC) Grant Announcement</u>

The Deputy Superintendent of Schools shared that UBC Okanagan is receiving a \$1 million Social Sciences and Humanities Research Council (SSHRC) grant over the next five years to establish a partnership research initiative to help educators decolonize curriculum and embed indigeneity into the classroom. Community partners include Central Okanagan Public Schools, Okanagan Nation Alliance, IndigenEYEZ, Kelowna Art Gallery, Kelowna Museums Society and the Universities of Alberta and Ottawa. The partnership will bring local Elders and Knowledge Keepers together with participating educators and the extended community. The goals and objectives of the SSHRC grant align with the recently signed five-year Equity in Action Agreement by the Central Okanagan Public Schools and the Indigenous communities:

- To co-design curricular pathways for educators and their students, to enhance understandings of Indigenous cultures and supports related to these groups; and, to mobilize local, place-based, land-based Indigenous ways of knowing/being.
- To facilitate professional inquiry opportunities to shift pedagogy/perspectives
- To bring our findings into conversation with university partners and co-applicants from the University of Alberta and the University of Ottawa.

BC Government News – Improving Outcomes for First Nations Children in Care

The Deputy Superintendent of Schools shared a news bulletin from the BC Government regarding Improving Outcomes for First Nations Children in Care. The First Nations Children and Youth in Care Protocol, signed May 26, 2020, commits the Province of BC and First Nations to work together to improve educational outcomes for children and youth in care and former youth in care. More information about the protocol will be forthcoming in fall.
