Presentation: School Opening Report - Part 1

The Superintendent reviewed the information provided for this year's school opening. The Central Okanagan School District is the 5th largest district in the province. The current District enrolment as of September 10, 2013 (21,452) shows an increase of 98 students over the enrolment numbers recorded on September 30, 2012 (21,354). Enrolment projections had indicated a decline of 185 students over the same period. Factors affecting enrolment numbers include in-migration from other communities/provinces, a rise in local birth rates, individual course funding at the secondary level which impacts the FTE count, and short-term and long-term international students attending through the District's International Education Program. TRUSTEES QUERIES/COMMENTS

Received a query from a parent requesting information on the possibility of providing all elementary students with education on locally grown food/produce in order to help them understand how food is grown and to make more informed, healthy food choices.

The Chair responded that the District's Health Promoting Schools Committee works with schools to promote healthy food choices by students. The Committee is open to the public and parent volunteers are encouraged to attend committee meetings. As well, there is a very active BC Fruit and Vegetable Program being provided in elementary schools. The District's Healthy Food Fair scheduled for September 24th provides parents from school PACS with the opportunity to look at options for meal programs that are healthier and locally sourced. A number of schools have also established school garden projects and local chefs are becoming involved in explaining to students the food preparation process for the produce they grow.

The Superintendent will investigate the possibility of having The Growing Chefs! Classroom Gardening Program provide a presentation to the Board. This item will be sent to the Coordinating Committee.
