The Superintendent of Schools/CEO presented the annual Report on Student Achievement, highlighting progress aligned with the District's Strategic Plan and the Framework for Enhancing Student Learning. The presentation showcased student success across academic, social, and career development domains. Key areas included improvements in literacy and numeracy, strong six-year completion rates (96% overall and 10% above the provincial average for Indigenous students), and expanded dual credit and career programs. The report also emphasized the District's continued commitment to equity, Indigenous education, and holistic student development.
