# Recognition:

1. Bruce McKay, Principal of Chute Lake Elementary School Recipient of Canada's Outstanding Principals Award

The Board of Education recognized Bruce McKay, Principal of Chute Lake Elementary School, for being selected by The Learning Partnership as one of *Canada's Outstanding Principals*. In Mr. McKay's words, "This award is shared with the school community of Chute Lake Elementary School who have collaborated to innovate, transform and create educational change".

#### Presentations:

- 1. "Inside 23"
  - a. Creating a Culture of Thinking at Chute Lake Elementary School

Bruce McKay and staff members of Chute Lake Elementary School presented their multi-year focus on 'creating a culture of thinking' which has resulted in deep, meaningful, and inclusive learning for their students.

#### **Action Items:**

## 1. Davidson Road Elementary School Enrolment

The following motion was brought forward at the January 13<sup>th</sup> Public Board Meeting:

THAT: The Board of Education redirect the overflow of students from Davidson Road Elementary School to Oyama Traditional School.

The Motion was tabled and forwarded to the Planning and Facilities Committee for further discussion.

## 2. BC Integrated Youth Services Initiative (BC-IYSI)

The Board of Education agreed to provide a Letter of Support for a BC Integrated Youth Services Initiative in the Central Okanagan.

3. Registration Dates for 2016/2017 School Year – Motion to Amend a Previously Approved Motion

The Board amended Motion 15P-180 (November 25, 2015) to read that the closing date of registrations, in order to apply the Board's registration priorities as established in Regulation 405R – Student Placement (Regulations), be set as <u>September 1, 2016</u>.

#### Information Items:

## 1. Superintendent's Emergent Issues

- The Superintendent advised that letters were sent to the Central Okanagan School District staff and school communities, expressing sympathies in relation to the recent La Loche tragedy and recognizing the importance of remaining vigilant during the critical period after a tragedy.
- The Joint Education Change Committee (JECC) is working hard to prepare for the upcoming Non-Instructional Day on February 9<sup>th</sup> which will bring together over 1300 teachers, principals, vice-principals, and senior staff to learn more about the redesigned curriculum.

# 1. Amendments to Regulations 405R – Student Placement

The amendments to Regulations 405R – Student Placement are to reflect the process for parents (or students who are living independently) registering at an out-of-catchment school after the formal registration period or throughout the school year.

In addition to the Level 4 and 5 Field Trip Summary – 2015/2016, the Board of Education was provided with information on the Kelowna Secondary School field trip scheduled for March 9 to 23, 2016 to the battlefields of France, Belgium and Germany. The District will continue to monitor Citizenship and Immigration Canada's travel advisory to ensure that the parents/students have the most accurate information available. A final meeting to review the trip and all available information regarding travel advisories will be held approximately two weeks prior to the scheduled departure date in order to make a final decision of whether or not the trip will proceed as planned.
