Annual Integrated Pest Management Report

The Director of Operations stated that as per Board Policy 620 - Integrated Pest Management, an annual report is to be provided to the Board of Education on the effectiveness of the District's Pesticide Management Program.

The Director of Operations provided an overview of the Integrated Pest Management (IPM) Report. The IPM Report outlines the mowing, field repair, weeding/mulching, trees/pruning, irrigation, and grounds projects completed from October 2021 to October 2022.

The Director of Operations answered queries from Committee Members. It was confirmed that the District does not use any chemicals for pest control.
